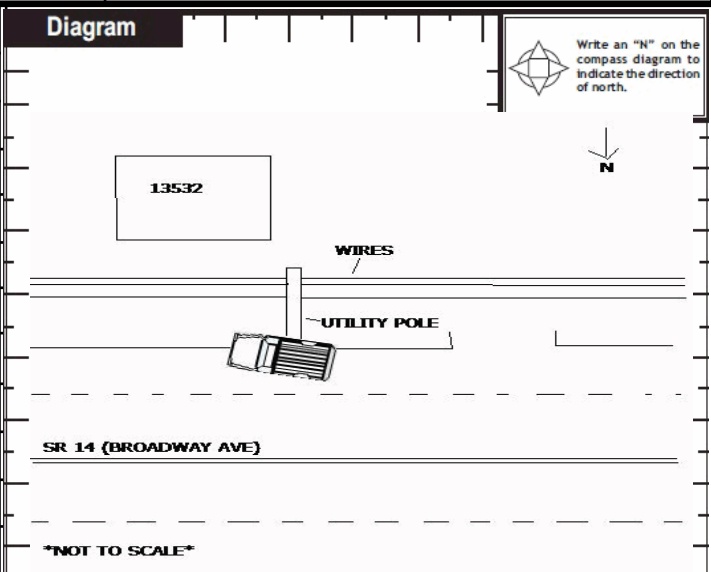

 UNIT 1 EXITED 135232 BROADWAY AVE (KURTZ BROS.) AND ATTEMPTED TO TURN E/B ONTO BROADWAY. THE DRIVER OF UNIT 1 FORGOT TO LOWER THE BOOM LIFT TO UNIT 1 AND IT STRUCK THE OVERHEAD CABLE AND TELEPHONE WIRES IN FRONT OF SAID ADDRESS. THE BOOM LIFT BECAME CAUGHT AROUND THE WIRES AND IT CAME TO REST AGAINST A TELEPHONE POLE, CAUSING UNIT 1 TO TO ALMOST ROLL OVER.


