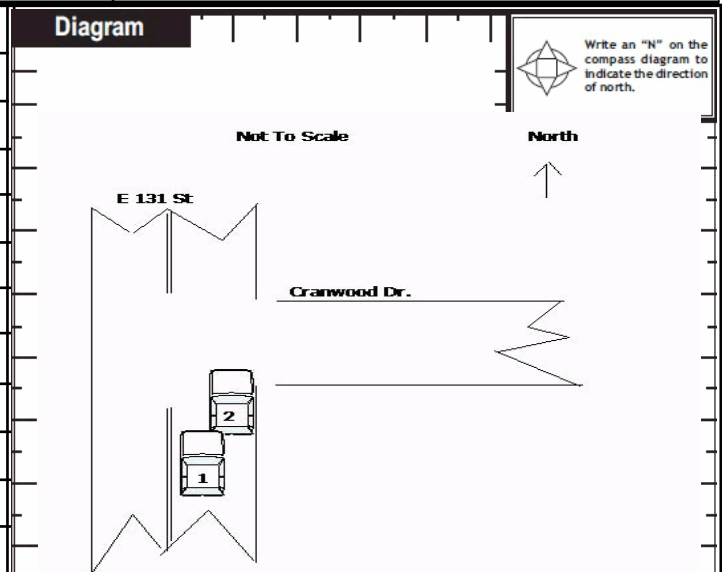

UNIT #1 WAS TRAVELING NORTH ON E 131 NEAR CRANWOOD DR. DIRECTLY BEHIND UNIT #2. UNIT #2 WAS SLOWING TO MAKE A RIGHT TURN ONTO CRANWOOD DR. UNIT #1 WAS FOLLOWING TO CLOSELY. AS A RESULT THE RIGHT FRONT OF UNIT #1 COLLIDED WITH THE LEFT REAR OF UNIT#2. UNIT #2 CONTINUED IN A NORTHERN DIRECTION . THE RIGHT SIDE OF UNIT #1 THEN SIDE SWIPE THE LEFT SIDE OF UNIT #2. BOTH UNITS WERE MOVED FROM FINAL REST AND THE DRIVER / PASSENGER WERE TRANSPORTED BY EMS PRIOR TO ARRIVAL.
