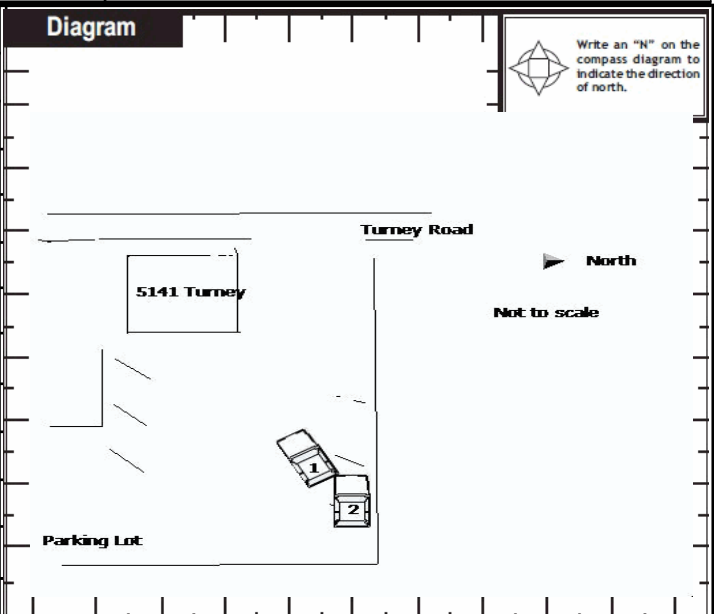

UNIT # 1 WAS BACKING IN A EASTWARD DIRECTION AT 5141 TURNEY. UNIT #2 WAS UNOCCUPIED AND LEGALLY PARKED FACING WEST AT 5141 TURNEY. UNIT #1 IMPROPERLY BACKED. AS A RESULT, THE RIGHT REAR OF UNIT #1 COLLIDED WITH THE LEFT FRONT OF UNIT #2. UNIT #2 WAS AT FINAL REST. UNIT #1 LEFT THE SCENE TRAVELING IN A WESTERN DIRECTION.

NOTE: DRIVER OF UNIT#1 WAS CONTACTED AND RETURNED TO THE SCENE. AT 16:36 ADVISED MIRANDA WARNINGS AND STATED, EATING WHILE BACKING GOT HOME AND SAW DAMAGE.
