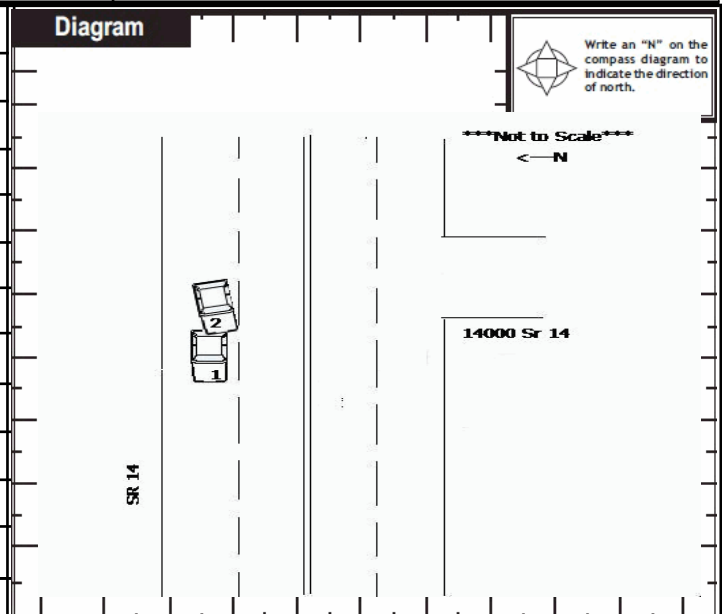

**Narrative**

DRIVER OF UNIT #1 WAS STOPPED IN HEAVY TRAFFIC IN THE CURB LANE WHILE ON SR 14 W/B AT 14000. UNIT #2 WAS DIRECTLY BEHIND UNIT #1, REAR-ENDED UNIT #1, AND FLED FROM THE CRASH SCENE. THE DRIVER OF UNIT #1 FOLLOWED UNIT #2 AND WAS ABLE TO GET A PLATE ON THE HIT/SKIP VEHICLE. THE DRIVER OF UNIT #2 WAS DESCRIBED AS A B/F, 20 YOA, AND TALKING ON HER CELL PHONE. CONTACT WAS BRIEFLY MADE TO THE OWNER OF UNIT #2. SHE DENIED BEING IN A CRASH AND HUNG UP. SHE REFUSED TO ANSWER THE PHONE AFTER SEVERAL ATTEMPTS MADE. ALSO, HER ADDRESS ON E.119 IN CLEVELAND IS VACANT.


