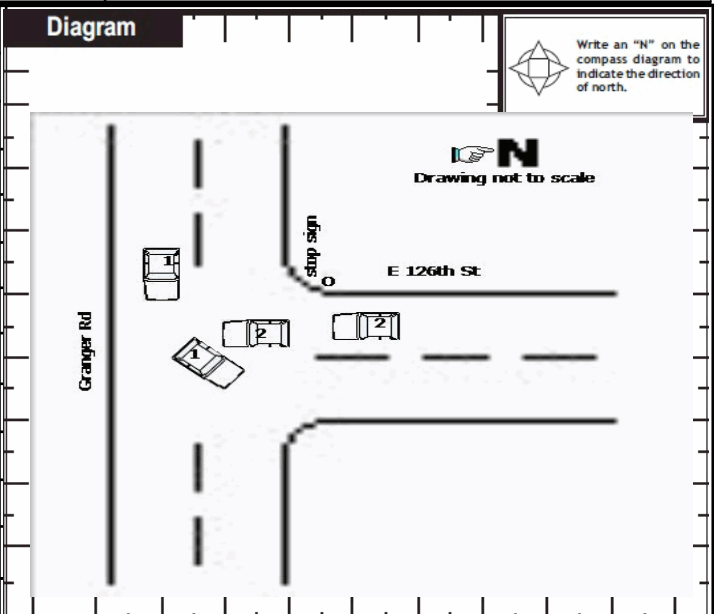

UNIT 2 STATES HE WAS ON E 126TH ST S/B AND WAS TURNING ONTO GRANGER RD E/B. UNIT 2 STATES HE CHECKED THE INTERSECTION AND DID NOT OBSERVE ANY VEHICLES. UNIT 2 STATES AS HE PULLED ONTO GRANGER HE OBSERVED UNIT 1 TURNING ONTO E 126TH ST. AT THAT TIME UNIT 2 BUMPER STRUCK UNIT 1.
