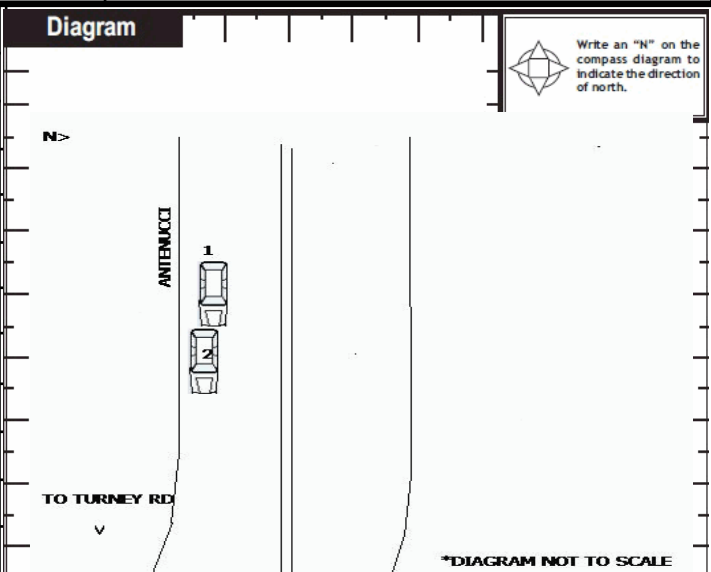

UNIT 1 WAS TRAVELLING EAST ON ANTENUCCI BLVD. APPROACHING TURNEY RD. UNIT 1 THEN REAR ENDED UNIT 2 WHO WAS PARKED WITH IT'S HAZARD LIGHTS ON ON THE RIGHT SIDE OF THE ROADWAY, DUE TO RUNNING OUT OF GAS. UNIT 2 WAS UNOCCUPIED AT TIME OF CRASH. DRIVER OF UNIT 1 STATES A THIRD VEHICLE WAS INVOLVED FORCING HIM INTO REAR ENDING UNIT 2. NO EVIDENCE OF A THIRD VEHICLE WAS DISCOVERED BY OFFICERS.
