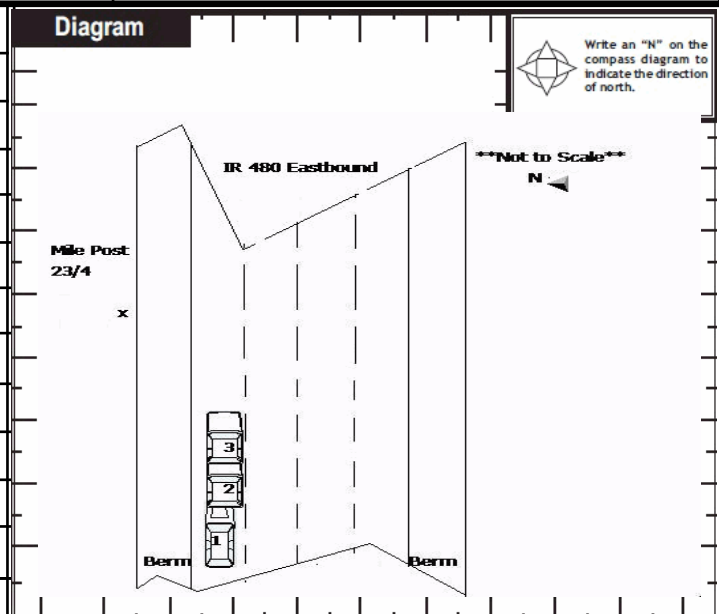

UNIT #1 WAS TRAVELING EAST ON IR 480 IN THE INSIDE LANE APPROXIMATELY 500' WEST OF MILE MAKER 23/4, DIRECTLY BEHIND UNIT #2. UNIT #2 WAS STOPPED FOR TRAFFIC DIRECTLY BEHIND UNIT #3. UNIT #3 WAS STOPPED FOR TRAFFIC. AS A RESULT, THE FRONT OF UNIT #1 COLLIDED WITH THE REAR OF UNIT #2. UNIT #2 TRAVELED EASTWARD AND THE FRONT COLLIDED WITH THE REAR OF UNIT #3. UNITS WERE AT FINAL REST UPON ARRIVAL.

NOTE: DRIVER OF UNIT# 3 STATED, SHE FELT ONE (1) IMPACT.




