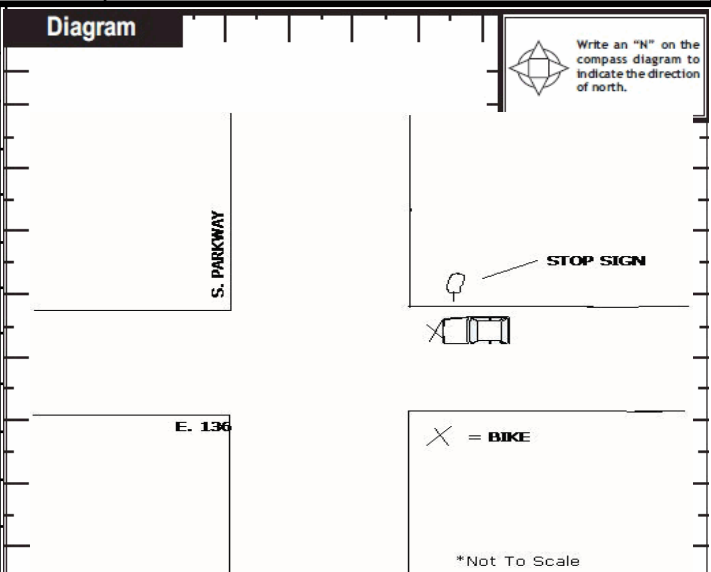

UNIT #2 WAS TRAVELLING N/B ON E. 136. UNIT #1 WAS TRAVELLING E/B ON S. PARKWAY. THE DRIVER OF UNIT #2 STATED HE STOPPED AT THE STOP SIGN A LITTLE FARTHER BACK. HE THEN PROCEEDED TO GO WHEN UNIT #1 SUDDENLY ENTERED THE STREET IN FRONT OF HIS VEHICLE. UNIT #2 STRUCK UNIT #1. THE DRIVER OF UNIT #1 ALONG WITH NUMEROUS WITNESSES STATED THE DRIVER OF UNIT #2 DIDN'T MAKE A COMPLETE STOP AT THE STOP SIGN AND "ROLLED THROUGH IT" STRIKING UNIT #1. 
