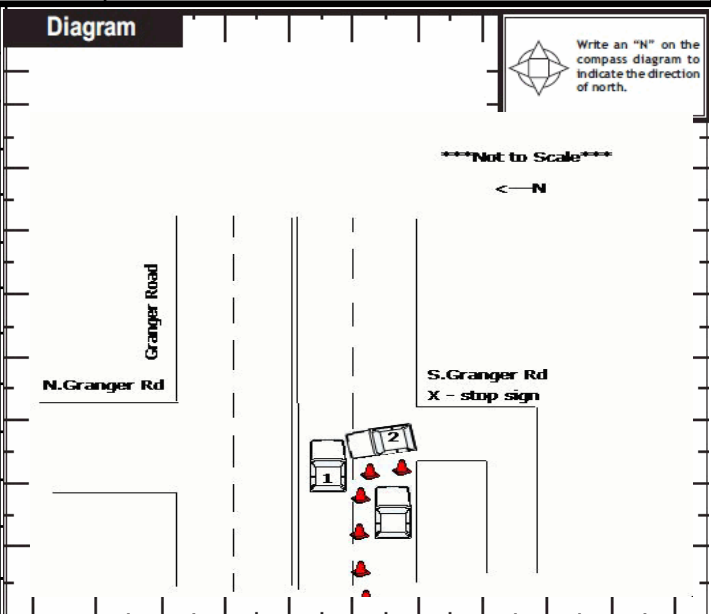

UNIT #1 WAS TRAVELLING E/B IN THE CENTER LANE ON SR 17 AT S. GRANGER ROAD. THE CURB LANE ON SR 17 E/B WAS CONED OFF DUE TO CONSTRUCTION AHEAD WHICH ENDED AT S. GRANGER ROAD. UNIT #2 WAS STOPPED AT THE STOP SIGN ON S.GRANGER ROAD N/B, PULLED FORWARD IN ATTEMPTS TO TURN W/B ONTO SR 17, AND STRUCK UNIT #1. DRIVER OF UNIT #2 STATED HE HAD A DIFFICULT TIME SEEING UPCOMING TRAFFIC PAST THE TRUCK PARKED IN THE CONED OFF CONSTRUCTION AREA. UNIT #1 WAS PRIVATELY TOWED FROM THE CRASH SCENE. UNIT #2 WAS A STATE OWNED O.D.O.T. PICK UP TRUCK.

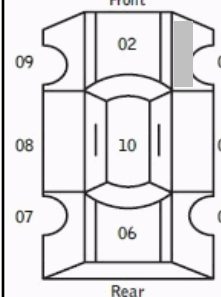

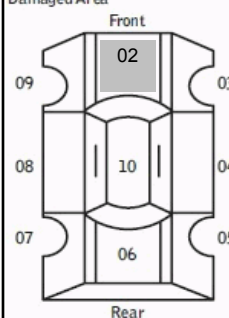
