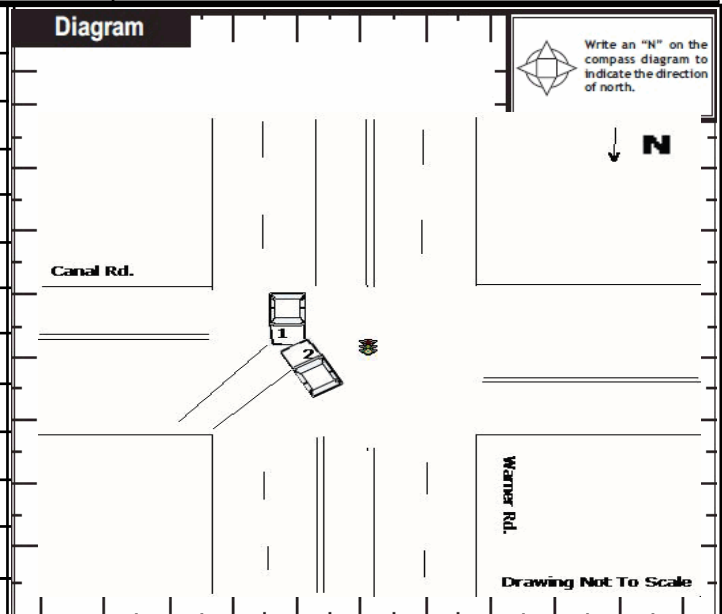

UNIT 1 WAS TRAVELING NORTHBOUND ON WARNER RD. IN THE LEFT LANE APPROACHING A GREEN LIGHT AT THE INTERSECTION OF CANAL AND WARNER. UNIT 2 WAS TRAVELING SOUTHBOUND ON WARNER APPROACHING INTERSECTION AT CANAL. UNIT 2 ATTEMPTED TO MAKE A LEFT TURN ON A GREEN LIGHT AND FAILED TO YIELD TO UNIT 1. WITNESS STATES THAT HE WAS IN RIGHT LANE NORTH ON WARNER NEXT TO UNIT 1. WITNESS STATED THAT THE LIGHT TURNED RED AND HE STOPPED, BUT UNITS 1 AND 2 BOTH RAN THE RED LIGHT, STRIKING EACHOTHER.


