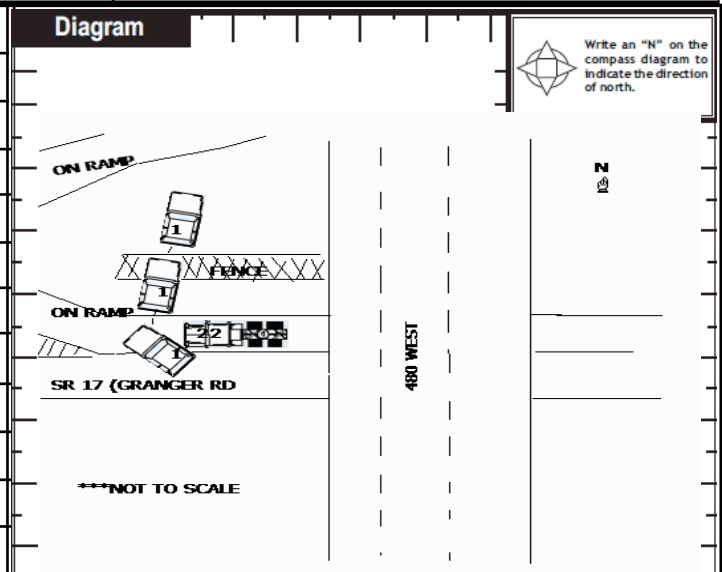

UNIT 2 WAS TRAVELING W/B ON SR 17 (GRANGER RD) IN THE RIGHT LANE. UNIT 1 WAS W/B ON SR 17 IN THE LEFT LANE AND ATTEMPTED TO DRIVE INTO THE RIGHT LANE. AS UNIT 1 WAS CHANGING LANES, UNIT 1 STRUCK THE LEFT FRONT OF UNIT 2, CAUSING UNIT 1 TO LOSE CONTROL. UNIT 1 THEN DROVE OVER THE CURB, OFF THE ROADWAY TO THE RIGHT AND THROUGH A FENCE AND CAME TO REST IN THE GRASS.





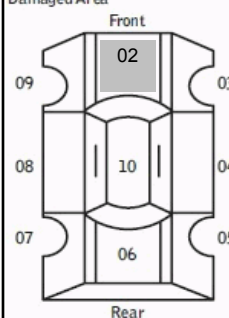
