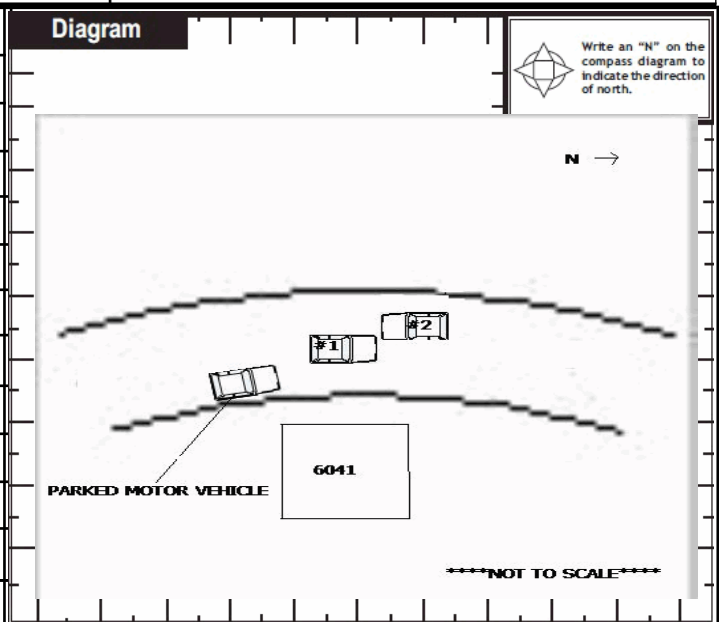

UNIT #1 WAS N/B ON ANDOVER BLVD. AND TRAVELLED LEFT ON THE ROADWAY TO GO AROUND A PARKED VEHICLE AND WAS STRUCK BY UNIT #2. DRIVER OF UNIT #2 STATED THAT HE WAS DRIVING MORE TOWARDS THE MIDDLE OF THE ROADWAY TO AVOID THE NUMEROUS POTHOLES, HE FURTHER STATED THAT HE WAS NOT LEFT OF CENTER WHEN THE VEHICLES COLLIDED. DRIVER OF UNIT #1 BELIEVES THAT UNIT #2 WAS SPEEDING. DRIVER OF UNIT #1 ALSO STATED THAT SHE THINKS THAT JEFFERY WASHINGTON WAS NOT THE DRIVER OF UNIT #2.


