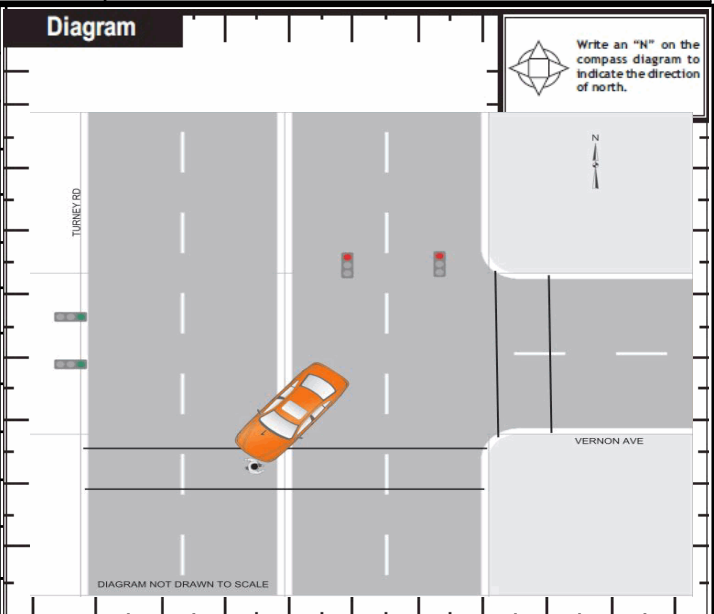

THE SIGNAL FOR UNIT 2 CYCLED TO GREEN ALLOWING UNIT 2 TO INITIATE A LEFT TURN ONTO S/B TURNEY. DUE TO SUN GLARE UNIT 2 FAILED TO OBSERVE AND YIELD TO UNIT 1 CAUSING UNIT 2 TO STRIKE UNIT 1.





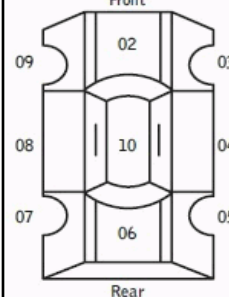
