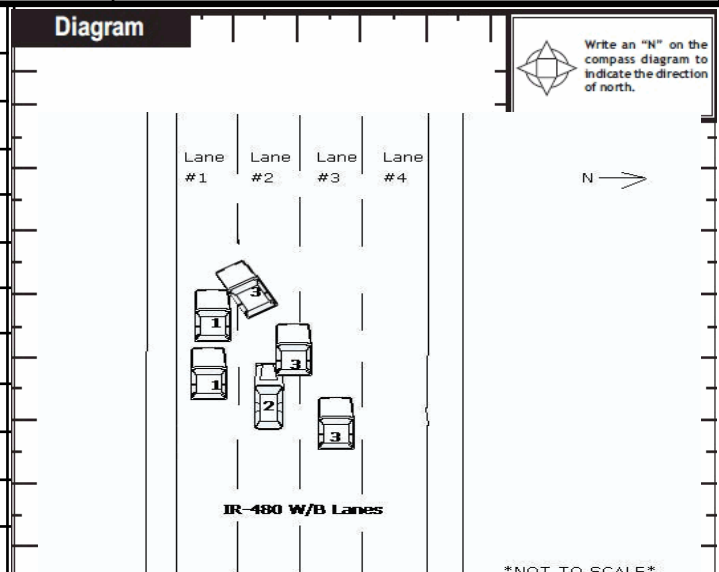

UNIT #3 THEN BEGAN TO LOSE CONTROL AND STRUCK UNIT #1 AND FLIPPED ONTO IT'S ROOF.






