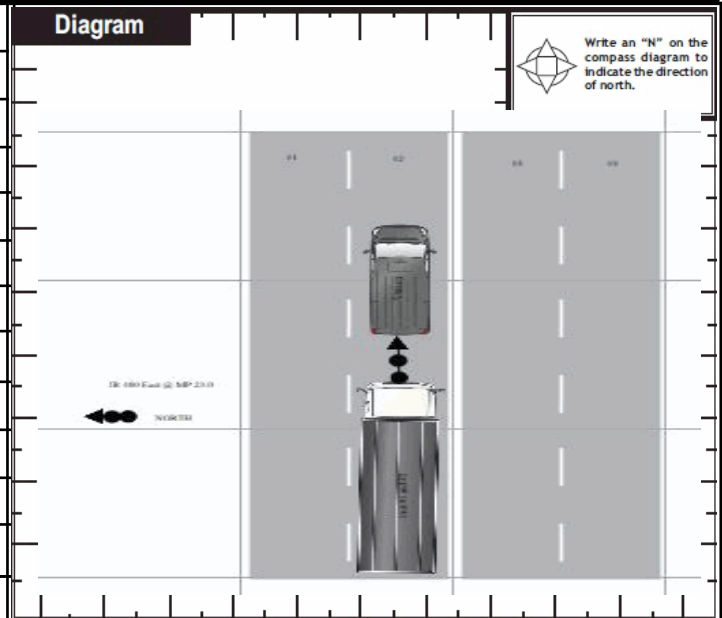

DRIVER OF UNIT #1 STATED HE WAS OPERATING PJD8751 TOWING TRAILER UNIT #2 TPM8095 ON IR480 E IN LANE #2. DRIVER OF UNIT 1 STATED HE OBSERVED TRAFFIC SLOW AHEAD AND WAS UNABLE TO SLOW IN TIME, SUBSEQUENTLY STRIKING UNIT #3 IN THE CENTER REAR. DRIVER OF UNIT #3 STATED HE WAS OPERATING ENB4760 ON IR480 E IN LANE #2. DRIVER OF UNIT #2 STATED HE WAS SLOWING IN TRAFFIC AND WAS SUBSEQUENTLY STRUCK IN THE CENTER REAR BY UNIT #1.


