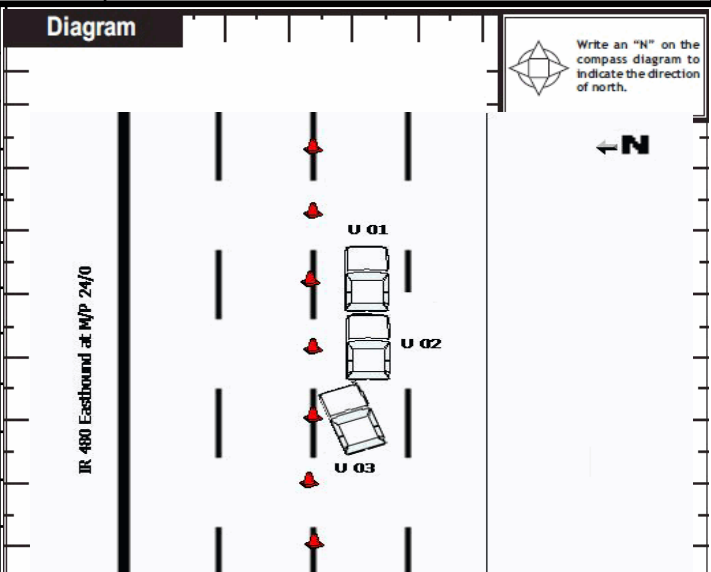

UNIT 01 WAS TRAVELING EAST ON I-480 AT MILE 24/0. UNIT 01 SLOWED DOWN FOR TRAFFIC AHEAD. UNIT 02 TRAVELING DIRECTLY BEHIND UNIT 01 ALSO ATTEMPTED TO SLOW DOWN AND STOP BUT WAS UNABLE TO STOP COMPLETELY CAUSING THE FRONT CENTER OF UNIT 02 TO STRIKE THE CENTER REAR OF UNIT 01. AS SOON AS UNIT 02 STRUCK UNIT 01, UNIT 03 WHICH WAS TRAVELING DIRECTLY BEHIND UNIT 02, ATTEMPTED TO SWERVE LEFT TO AVOID STRIKING UNIT 02. UNIT 03 WAS UNABLE TO AVOID UNIT 02 AND THE FRONT RIGHT CORNER OF UNIT 03 STRUCK THE LEFT REAR CORNER OF UNIT 02.
