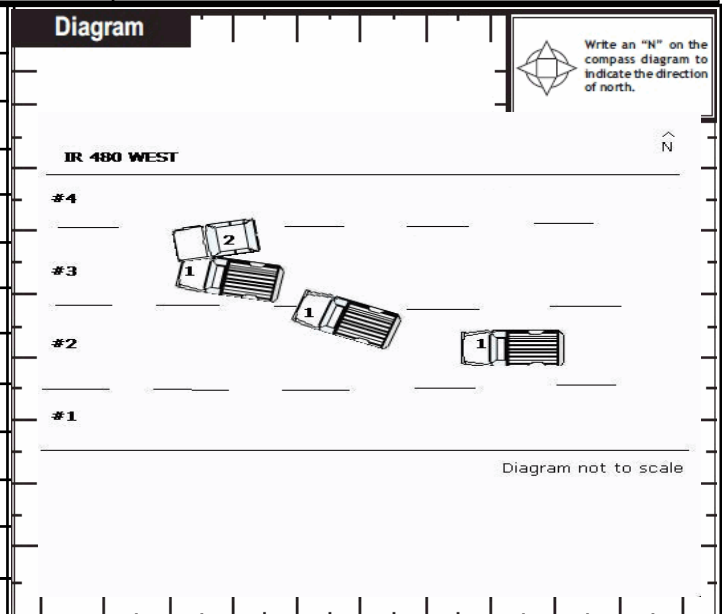

UNIT 1 WAS TRAVELING WESTBOUND IN THE #2 LANE ON IR-480 WEST. THE DRIVER OF UNIT 1 STATED HE ACTIVATED HIS RIGHT TURN SIGNAL, SIGNIFYING HIS INTENTIONS TO MERGE INTO LANE #3. DRIVER OF UNIT 1 STATED HE MADE SURE THE LANE WAS CLEAR OF ALL TRAFFIC AND BEGAN MERGING INTO LANE #3. AS UNIT 1 WAS MERGING INTO LANE #3, A BLUE/GREEN NISSAN MAXIMA CAME TRAVELING AT A HIGH RATE OF SPEED, WESTBOUND, ALSO ATTEMPTING TO MERGE INTO LANE #3. ACCORDING TO THE DRIVER AND PASSENGER OF UNIT 1, THE MAXIMA WAS TRAVELING AT A HIGH RATE OF SPEED AND SIDE SWIPED THE FRONT RIGHT CORNER OF

ON 10/18/18, OFC. SIMIA SPOKE WITH A WITNESS TO THE ACCIDENT, "GUY DIFINI", WHO RELATED THE FOLLOWING; MR. DIFINI STATED HE WAS FOLLOWING UNIT 1 FOR A FEW MILES PRIOR TO THE MVA. DIFINI STATED THE DRIVER OF UNIT 1 WAS DRIVING RECKLESSLY AND SPEEDING. DIFINI STATED AS UNIT 1 AND UNIT 2 WERE APPROACHING THE VALLEY VIEW BRIDGE, UNIT 1 WAS TRAVELING IN THE HIGH SPEED LANE (LANE #1). DIFINI STATED UNIT 1 THEN SUDDENLY, WITHOUT REGARD FOR TRAFFIC, MERGED OVER TWO LANES TO THE RIGHT (LANE #3), AND STRUCK UNIT 2 WHICH WAS ALREADY IN LANE #3.


