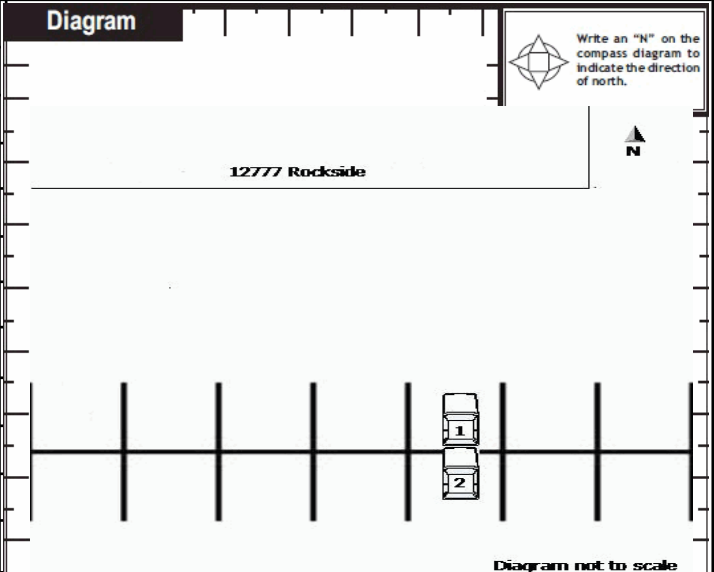

DRIVER OF UNIT 1 STATES SHE WAS SITTING IN HER VEHICLE IN A PARKING SPOT IN THE LOT OF 12777 ROCKSIDE (WALGREENS) AND UNIT 2 PULLED INTO A PARKING SPOT BEHIND HER AND STRUCK THE REAR OF UNIT 1.

DRIVER OF UNIT 2 EXITED HER VEHICLE AND SPOKE BRIEFLY WITH THE DRIVER OF UNIT 1 AND THEN GOT BACK INTO UNIT 2 AND STATED THAT "SHE WAS NOT STAYING AROUND BECAUSE SHE WARRANTS". UNIT 2 THEN LEFT THE AREA W/B ON ROCKSIDE. UNIT 2 WAS DESCRIBED AS A BLACK SUV WITH FRONT END DAMAGE BEING DRIVEN BY A "YOUNGER, LIGHT SKIN B/F IN THE
