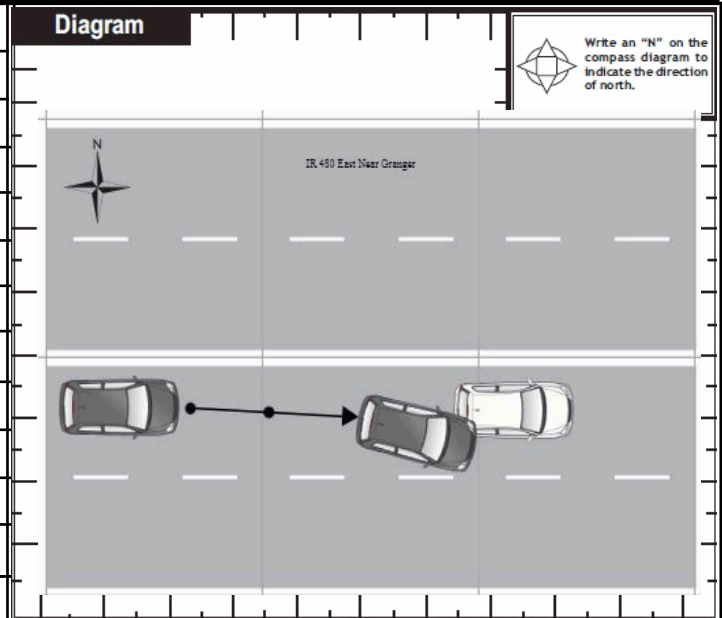

DRIVER OF UNIT #1 STATED SHE WAS TRAVELING ON IR480 E NEAR GRANGER IN LANE #3. SHE OBSERVED TRAFFIC SLOW AHEAD BUT WAS UNABLE TO STOP IN TIME, SUBSEQUENTLY STRIKING UNIT #2 IN THE RIGHT REAR.

DRIVER OF UNIT #2 STATED HE WAS TRAVELING ON IR480 E NEAR GRANGER IN LANE #3. DRIVER OF UNIT #2 WAS SLOWING IN TRAFFIC AND WAS SUDDENLY STRUCK BY UNIT #1.




