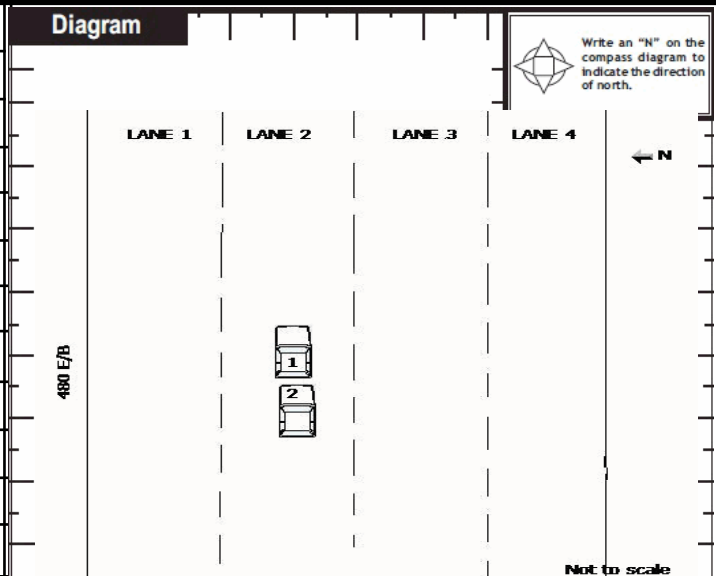

DRIVER OF UNIT 2 STATES HE WAS TRAVELING IR 480 E/B IN LANE 2 BEHIND UNIT 1. UNIT 1 WAS INVOLVED IN THE COLLISION WITH ANOTHER VEHICLE AND STOPPED ABRUPTLY. DRIVER OF UNIT 2 WAS UNABLE TO STOP AND STRUCK UNIT 1.


