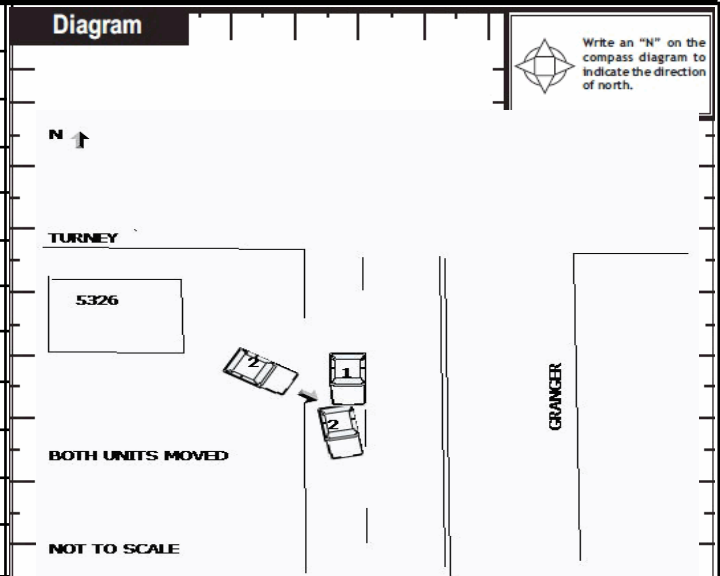

UNIT 1 WAS S/B ON TURNEY AT GRANGER. UNIT 2 WAS EXITING THE PARKING LOT AT 5326 TURNEY ONTO S/B TURNEY. UNIT 2 THEN PULLED IN FRONT OF UNIT 1 CAUSING UNIT 1 TO STRIKE UNIT 2 IN LEFT REAR. UNIT 1 ATTEMPTED TO SWERVE LEFT TO AVOID UNIT 2. THE DEBRIS FROM THE ACCIDENT WAS LOCATED APPROXIMATELY 10 FT SOUTH FROM THE DRIVEWAY UNIT 2 EXITED




