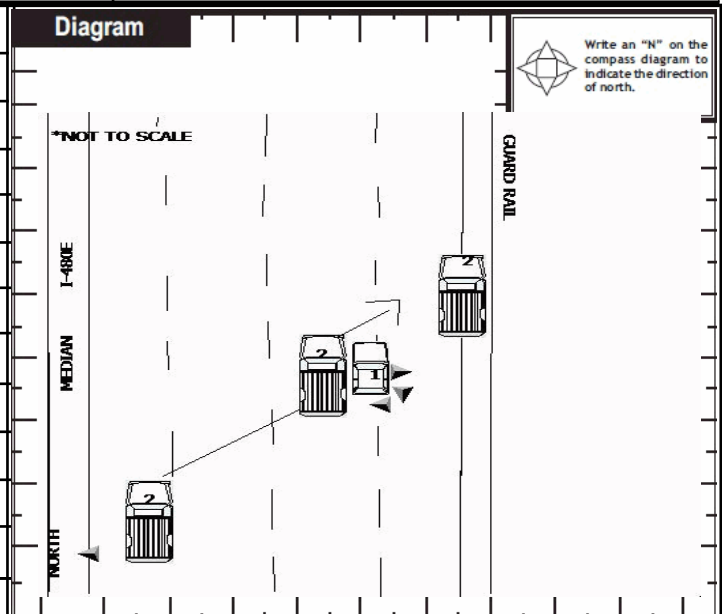

UNIT 1 WAS TRAVELING ON 480 E BEFORE BROADWAY IN THE SLOW SPEED LANE. UNIT 2 WAS TRAVELING ON 480 E IN THE HIGH SPEED LANE. UNIT 2 CHANGED LANES AND SIDE SWIPED UNIT 1 LEFT SIDE, CAUSING UNIT 1 TO SPIN. UNIT 2 THEN CONTINUED ON TO STRIKE THE GUARD RAIL OF THE SLOW LANE ON IT'S LEFT SIDE.


