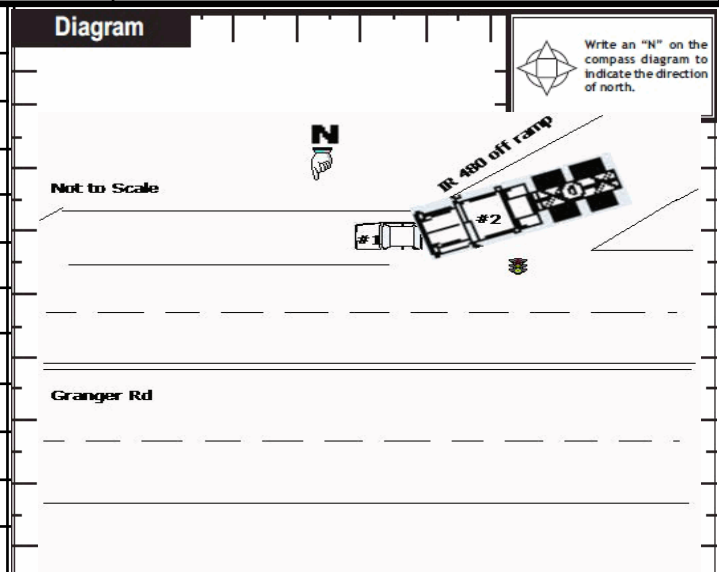

UNIT 1 STATES SHE WAS MAKING A RIGHT TURN OFF THE IR 480 EXIT WHEN SHE STOPPED FOR TRAFFIC. AT THIS TIME UNIT 1 STATES SHE WAS STRUCK AT THE REAR BY UNIT 2. UNIT 2 STATES HE WAS ON THE OFF RAMP AT THE TRAFFIC SIGNAL WITH NO VEHICLES TO HIS FRONT. ON THE GREEN LIGHT, UNIT 2 TURNED RIGHT AT WHICH TIME HE STATES HE HEARD A THUMB. UNIT 2 STATES HE OBSERVED THE DRIVER OF UNIT 1 WHO APPEARED TO BE IN DISTRESS. AT THIS TIME UNIT 2 WAS ADVISED BY UNIT 1 THAT HE STRUCK HER AT THE REAR.

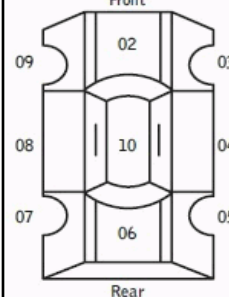
