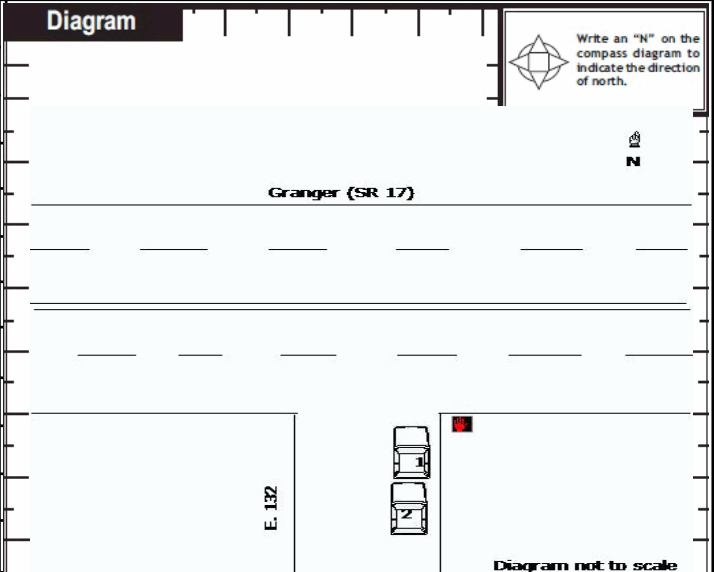

HOWEVER, THE BRAKES IN UNIT 2 WERE NOT FUNCTIONING AND SHE WAS UNABLE TO STOP CAUSING UNIT 2 TO STRIKE UNIT 1


