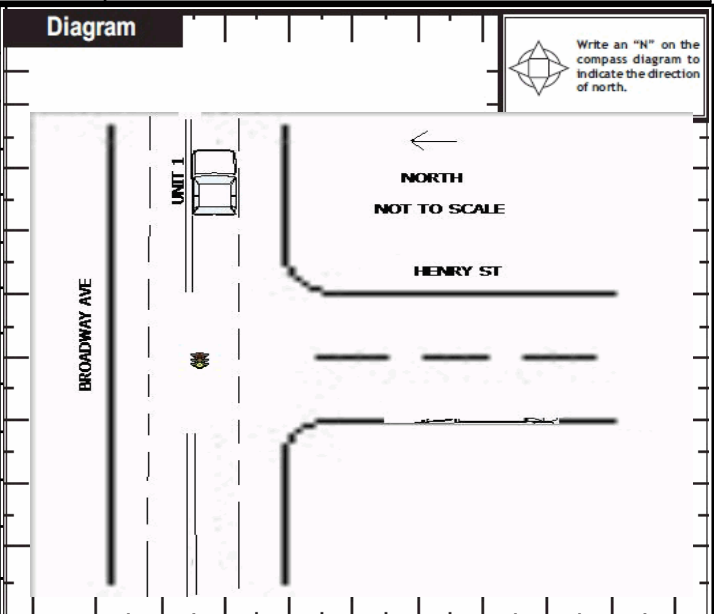

ON DECEMBER 22, 2018 AT ABOUT 0215 HOURS UNIT 1 WAS FOUND ON BROADWAY AVE. NEAR HENRY ST. DISABLED AND APPEARED TO HAVE STRUCK A CURB CAUSING HEAVY DAMAGE ONLY TO THE FRONT PASSENGER SIDE RIM, FLATTENING THE PASSENGER REAR TIRE AND CAUSING AIR BAG DEPLOYMENT. THE DRIVER OF UNIT 1 WAS UNABLE TO RECALL STRIKING ANY OBJECT OR VEHICLES. OFFICERS THOROUGHLY CHECKED THE AREA WITH NO RESULTS OF ANY PROPERTY DAMAGE OR OTHER INVOLVED VEHICLE. BASED ON THE EXTENT OF THE DAMAGE TO THE RIM IT IS ESTIMATED BY OFFICERS THAT THE MVA OCCURRED
