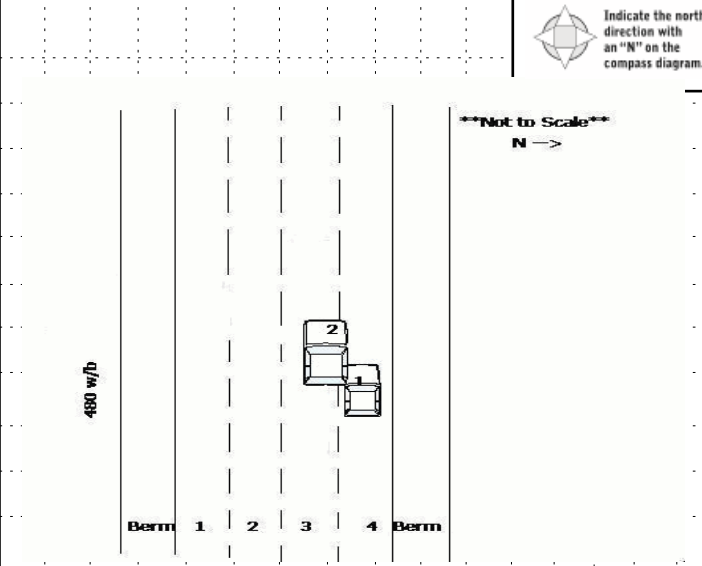

HE NOTICED A DARK COLORED SUV TRAVELING AT A HIGH RATE OF SPEED TRAVELING IN THE SAME DIRECTION IN THE LEFT LANE RIGHT NEXT TO THEM CUT THEM OFF. THE PASSENGER OF UNIT #1 STATED AT THAT TIME THE REAR PASSENGER SIDE BUMPER OF UNIT #2 MADE CONTACT WITH UNIT #1 FRONT DRIVER SIDE FENDER CAUSING THE DRIVER OF UNIT #1 TO

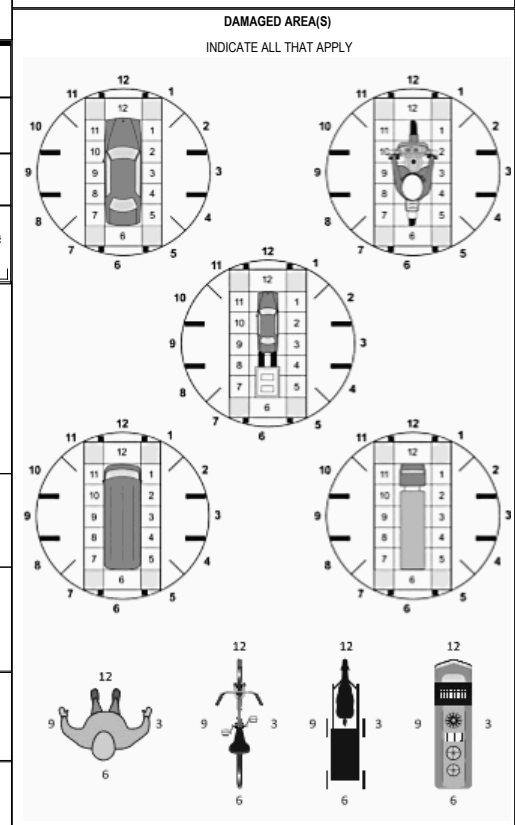

He noticed a dark colored SUV traveling at a high rate of speed traveling in the same direction in the left lane right next to them cut them off. The passenger of Unit #1 stated at that time the rear passenger side bumper of Unit #2 made contact with Unit #1 front driver side fender causing the driver of Unit #1 to loose control and slammed into the wall causing disabling damage. The driver of Unit #2 stated she was traveling west bound on 480 passing the on ramp from Transportation when she observed Unit #1 coming onto 480. The driver of Unit #2 stated as she continued to travel west bound in lane #3 Unit #1 who was in lane #4 all of a sudden merged into her lane causing the front driver side bumper to make contact with Unit #2 passenger side rear fender and wheel. After speaking with both parties I was unable to determine who was at fault of the accident.</p>
