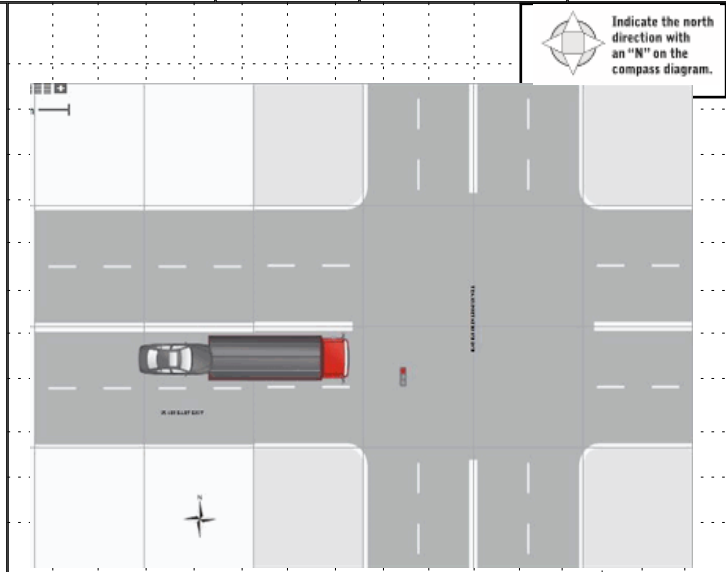

NARRATIVE

DRIVER OF UNIT #2 STATED SHE WAS STATIONARY AT THE TRAFFIC CONTROL DEVICE AT THE INTERSECTION OF IR480E EXIT AND TRANSPORTATION. UNIT #1 WAS STOPPED AHEAD OF HER AND BEGAN SLOWLY BACKING UNTIL UNIT #1 STRUCK UNIT #2 IN THE CENTER FRONT, CAUSING DAMAGE TO THE HOOD OF THE VEHICLE. UNIT #1 THEN PROCEEDED ON ITS ROUTE AND LEFT THE SCENE OF THE CRASH. THE TRUCK WAS DESCRIBED AS A RED TOW TRUCK WITH "LAKE EFFECT TOWING" DECALS.

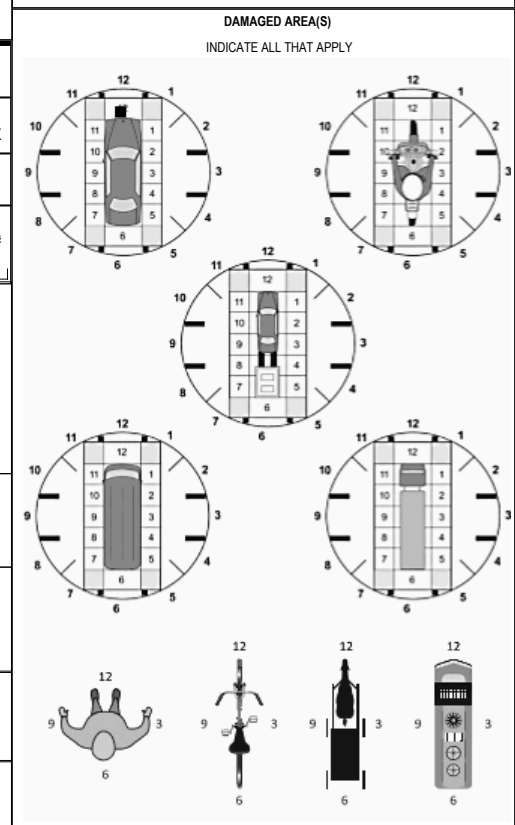
