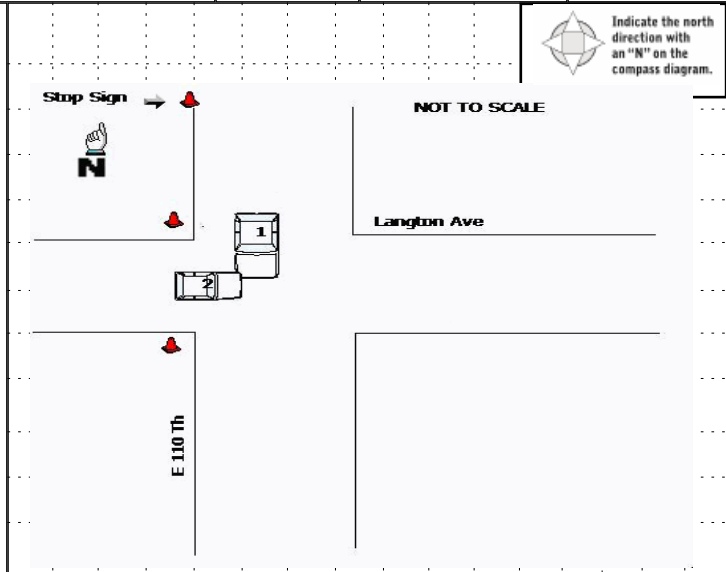

THE DRIVER OF UNIT #1 STATED WHEN SHE PROCEEDED TO TRAVEL SOUTH BOUND, UNIT #2 APPEARED OUT OF NOWHERE AND RAN THE STOP SIGN WHICH CAUSED THE FRONT BUMPER OF UNIT #2 TO MAKE CONTACT WITH UNIT #1 FRONT PASSENGER SIDE FENDER. THE DRIVER OF UNIT #1 STATED WHEN BOTH VEHICLES CAME TO REST, THE DRIVER OF UNIT #2 SPEED OFF SOUTH BOUND THEN MADE A LEFT HAND TURN AT THE FIRST STOP SIGN THEN

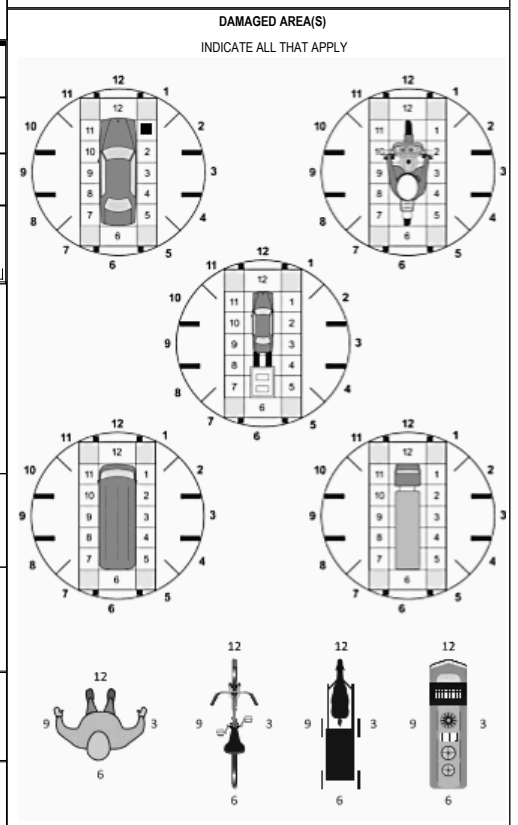
