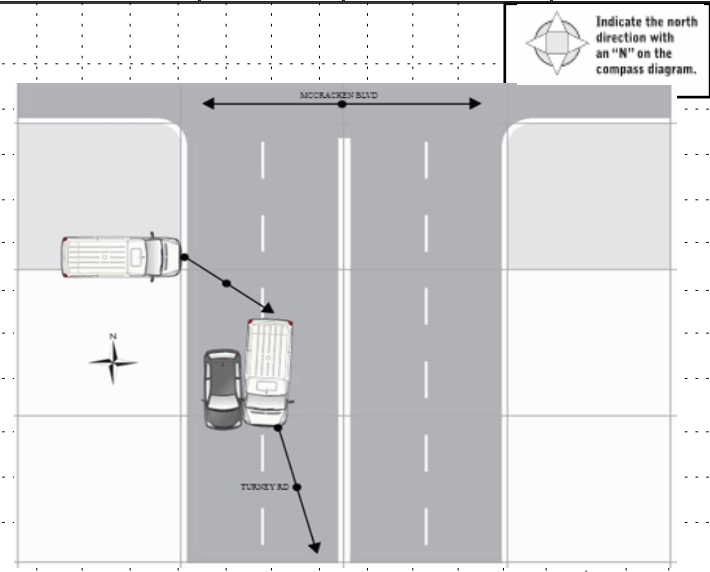

DRIVER OF UNIT #1 STATED HE OBSERVED UNIT #2 (HIT-SKIP UNIT) PULL OUT OF A PRIVATE DRIVEWAY FROM SPEEDWAY GAS STATION AND ATTEMPT TO PASS UNIT #1. UNIT #2 SUBSEQUENTLY STRUCK UNIT #1 ON THE LEFT FRONT WHEEL WELL AREA. 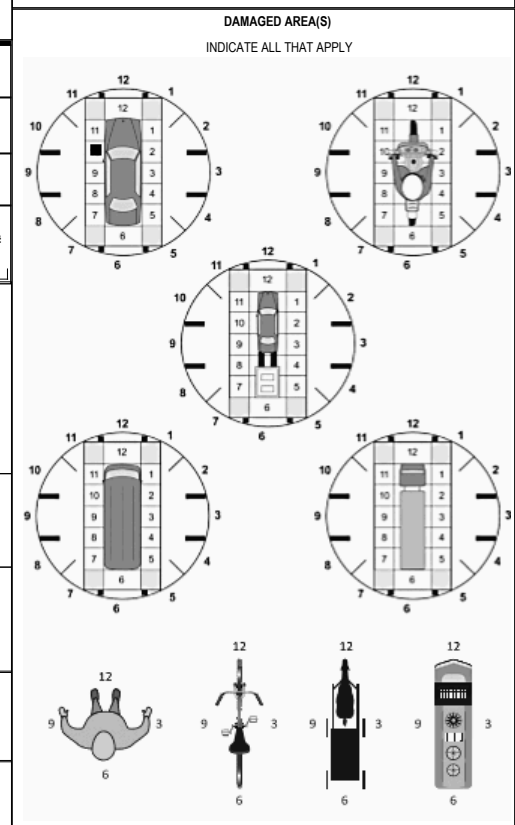
