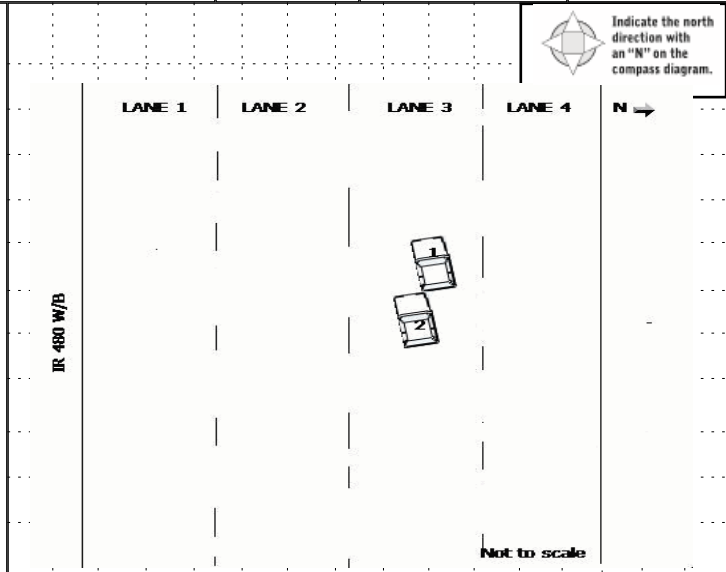

DRIVERS OF BOTH UNIT 1 AND UNIT 2 STATED THEY WERE TRAVELING IN LANE 3 ON IR 480 W/B AND A VEHICLE IN FRONT OF UNIT 1 STOPPED ABRUPTLY. UNIT 1 THEN SWERVED SLIGHTLY TO AVOID THAT VEHICLE AND UNIT 2 SWERVED SLIGHTLY TO ATTEMPT TO MISS UNIT 1, HOWEVER UNIT 2 COLLIDED WITH UNIT 1.

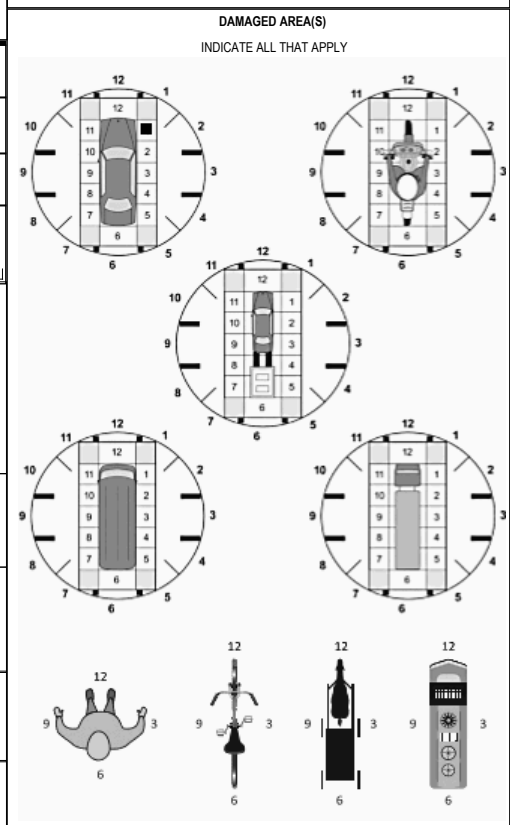

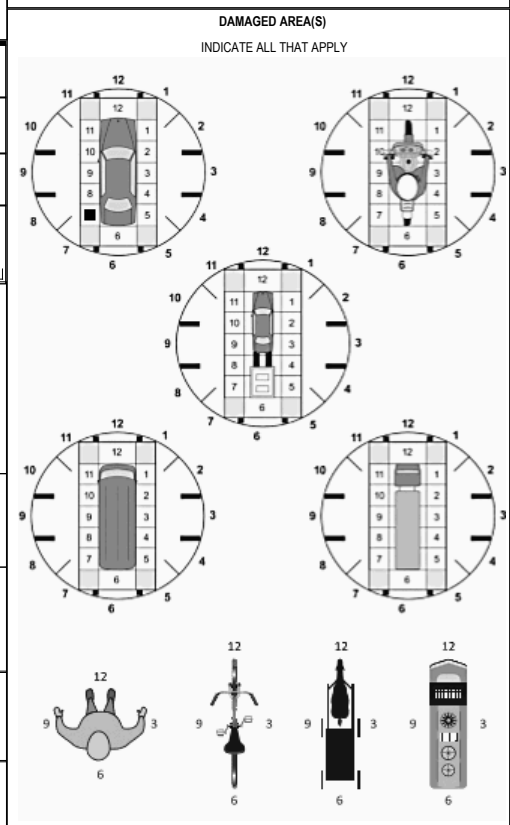
