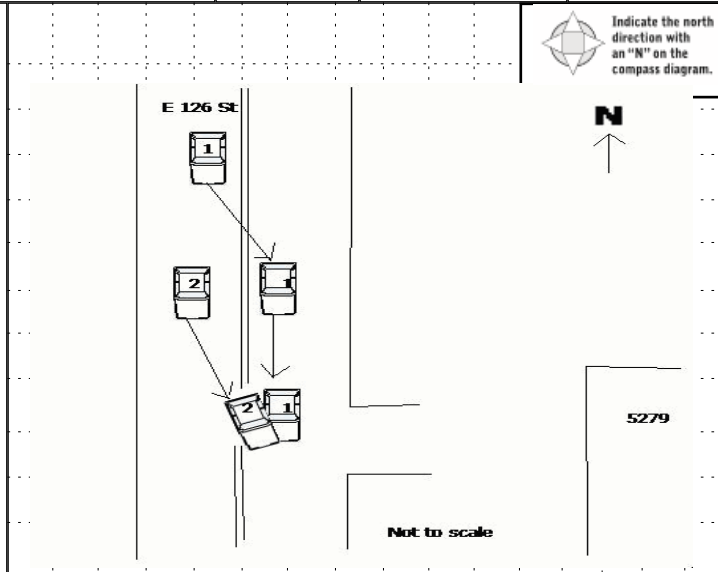

 UNIT TWO WAS THE SECOND VEHICLE TRAVELING SOUTH IN FRONT OF UNIT ONE. UNIT TWO HAD ITS HAZARD LIGHTS ON AND WAS TRAVELING AT A SLOW SPEED. THE VEHICLE IN FRONT OF UNIT ONE CROSSED THE DOUBLE YELLOW LINE AND BEGAN TO PASS UNIT TWO. UNIT ONE FOLLOWED THE OTHER VEHICLE TO PASS UNIT TWO. AS UNIT ONE WAS PASSING UNIT TWO UNIT TWO MADE A LEFT TURN IN FRONT OF HER CAUSING THE COLLISION.

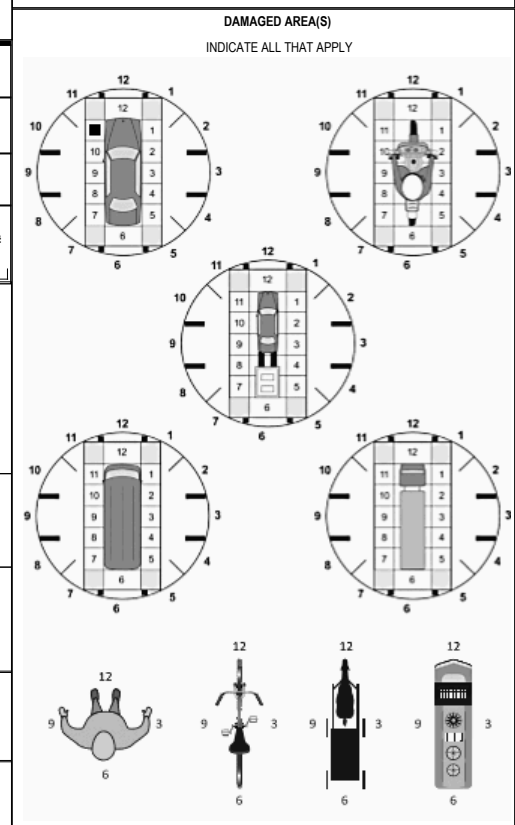

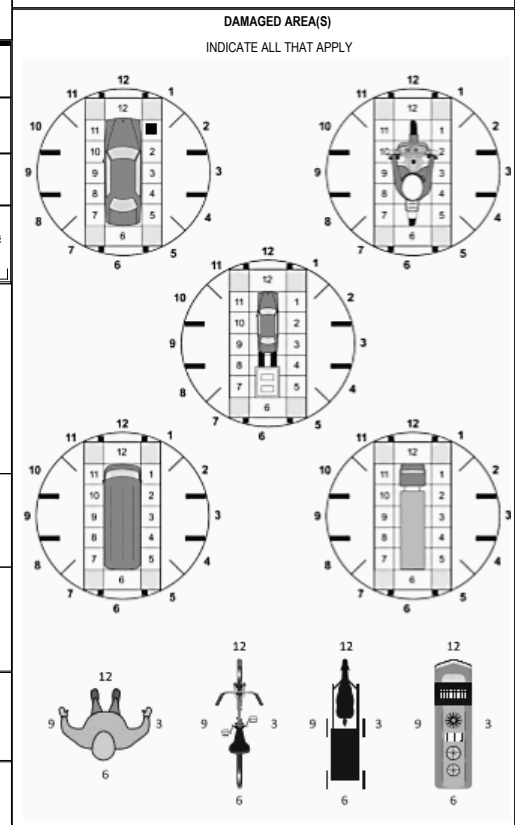
