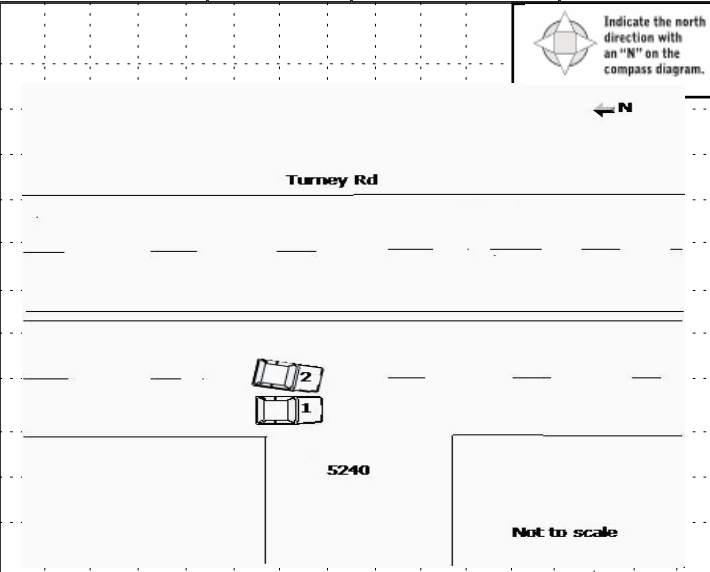

Unit 2 then drove into the lot, stopped and the driver exited unit 2, looked at the damage to the vehicle then got back into the vehicle and left the lot n/b on Turney. Unit 2 was then observed making a right (e/b) turn onto Wallingford.</p> <p>A second witness, Shawn Carter, was seated in the restaurant and observed the MVA occur in front of the building. Carter reiterated the same details that Walker stated about the incident. Both Walker and Carter advised that the vehicle was a white Chevy Malibu being driven by a younger b/f with long hair. Neither party was able to obtain a registration for the vehicle.</p> <p>Video footage of the vehicle in question was observed on the security cameras on the outside of the building. It was able to be confirmed that the vehicle was a white Chevy Malibu with tinted windows being driven by a female. However, no plate was able to be obtained from this video footage.</p>
