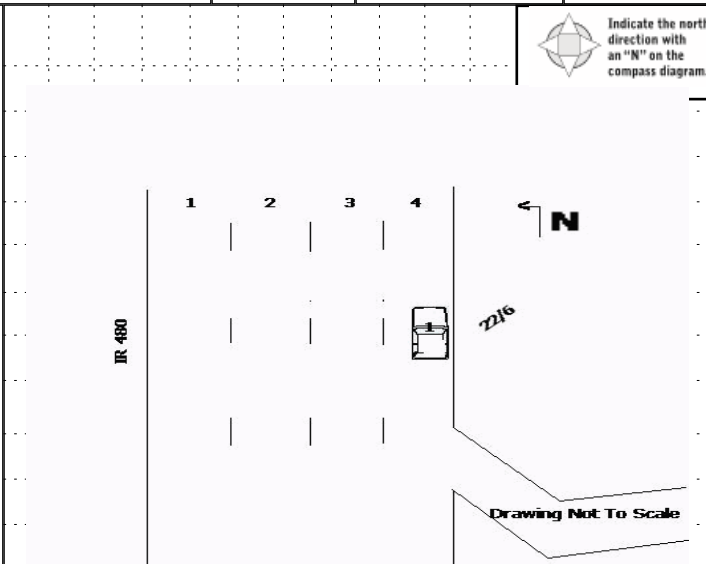

 UNIT 1 WAS TRAVELING ON THE IR 480 EAST ON RAMP FROM TRANSPORTATION BL. AS UNIT 1 WAS MERGING INTO TRAFFIC, UNIT 1 DID NOT SEE A METAL TRUCK PART LYING IN LANE 4 WHICH UNIT 1 WAS ENTERING. UNIT 1 RAN OVER THE TRUCK PART AT MILE POST 22.6 WHICH CAUSED UNIT 1 TO TRAVEL ONTO THE RIGHT BERM DUE TO THE DRIVER'S SIDE FRONT AND REAR TIRE IMMEDIATELY GOING FLAT. BOTH THE RIMS OF THE EACH TIRE WERE ALSO BENT.
