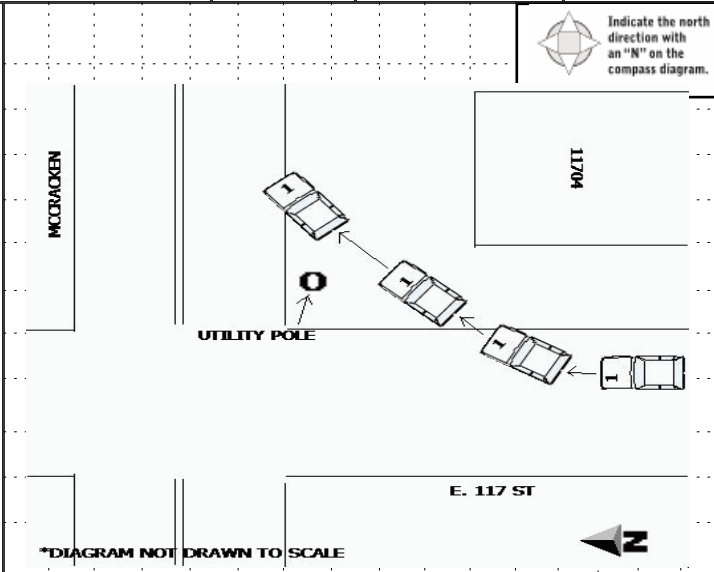

 UNIT 1 WAS TRAVELING N/B ON E. 117 APPROACHING MCCRACKEN. WITH A SNOW COVERED ROADWAY UNIT 1 ATTEMPTED TO STOP IN TIME FOR THE STOP SIGN AT MCCRACKEN. THE OPERATOR OF UNIT 1 LOST CONTROL CAUSING UNIT 1 TO TRAVEL OFF OF THE ROAD TO THE RIGHT INTO THE YARD OF 11704 MCCRACKEN. UNIT 1 CONTINUES TO TRAVEL N/E THROUGH THE YARD AND THEN COMES TO REST AFTER STRIKING THE SOUTH CURB OF MCCRACKEN CAUSING DAMAGE TO THE LEFT FRONT OF UNIT 1.
