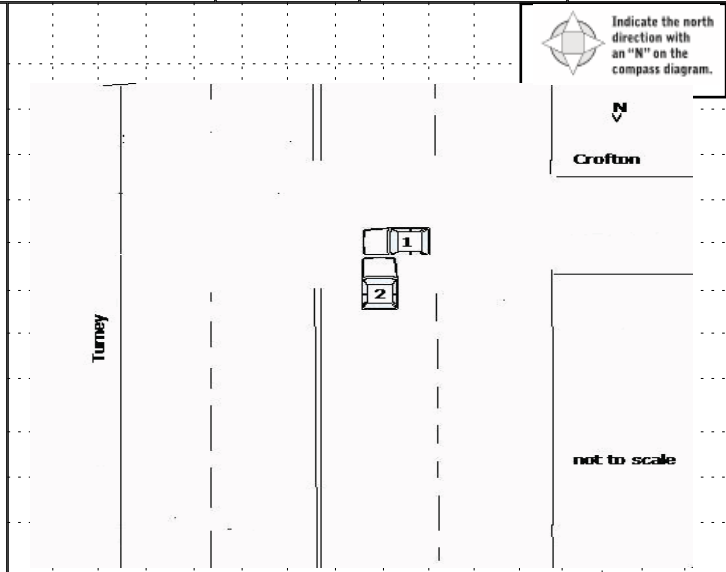

DRIVER OF UNIT 2 STATES THAT HE WAS TRAVELING S/B ON TURNEY AND DID NOT SEE THE RED LIGHT. AFTER NOTICING UNIT 1 ENTER THE INTERSECTION, HE ATTEMPTED TO STOP BUT SLID INTO THE SIDE OF UNIT 1.
