 UNIT #1 BACKED OUT OF THE PARKING SPACE AND BEGAN TO GO FORWARD AND THE DRIVER STATED HIS BRAKES DIDN'T ENGAGE RIGHT AWAY AND HE STRUCK UNIT #2 IN THE LEFT REAR BUMPER WITH THE FRONT OF UNIT #1 CAUSING MINOR REAR END DAMAGE TO UNIT #2. 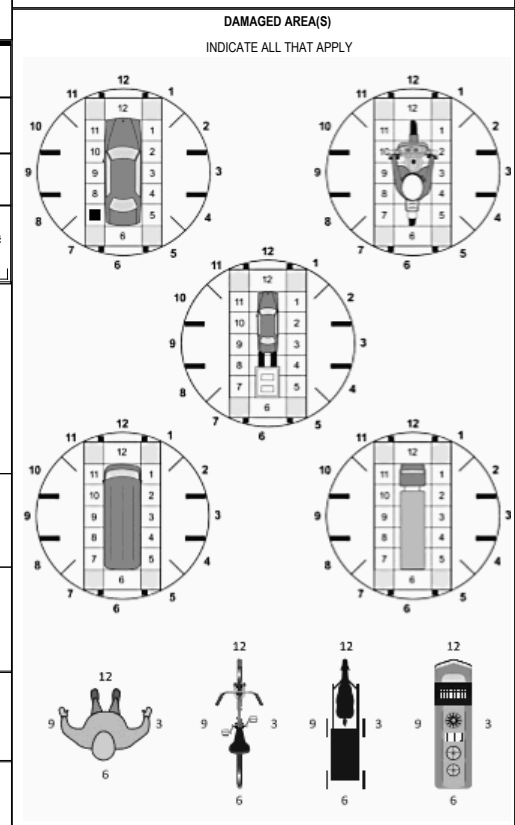

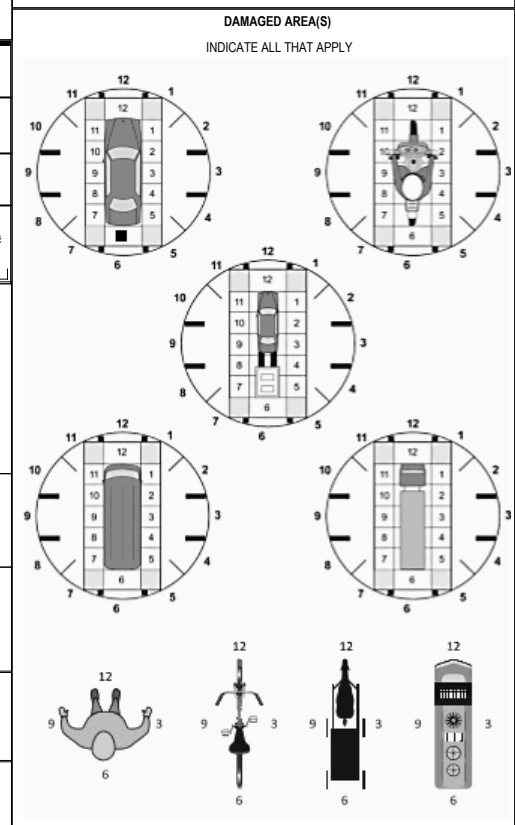
