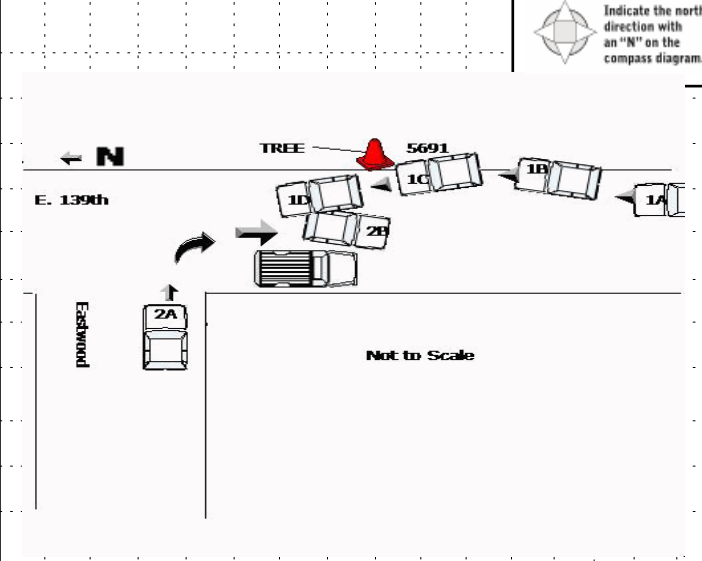

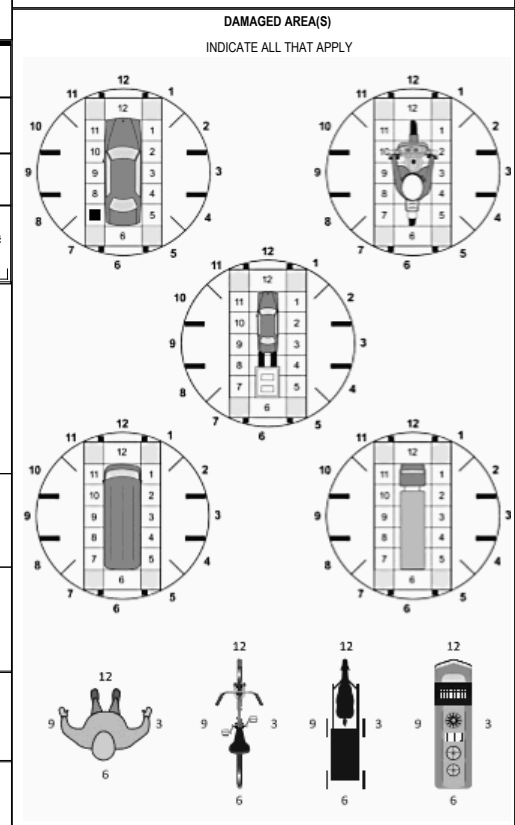

Unit 2 stated Unit 1 appeared to had stopped to allow Unit 2 to proceed but then Unit 1 suddenly continued N/B, driving off the roadway right, then back onto the roadway and struck the left rear of Unit 2. Unit 2 driver stated she stopped where her vehicle was struck and did not move the vehicle. Unit 2's resting place was photographed for the report.</p> <p>Unit 1 stated she was traveling N/B on E. 139th when Unit 2 made a wide right turn onto E. 139th, crossing the center line. Unit 1 states she drove off the right side of the roadway to avoid Unit 2 but then back onto the roadway to avoid a tree in the tree lawn.
