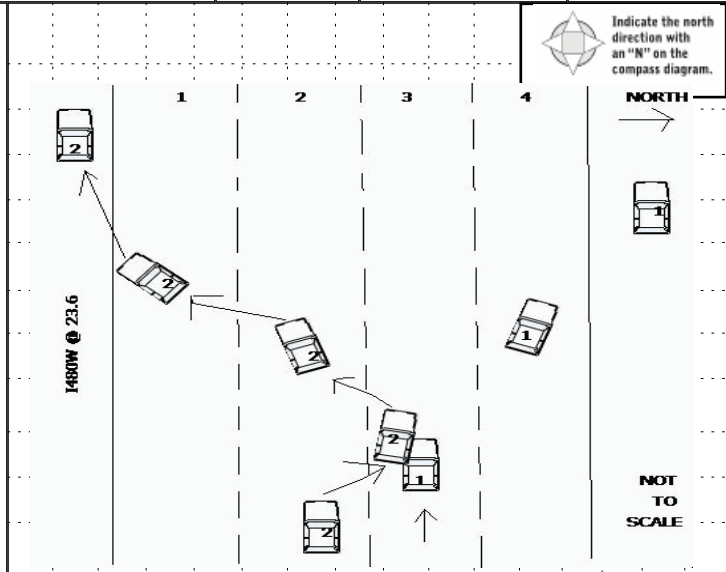

NARRATIVE

OPERATOR OF UNIT 1 WAS TRAVELING WEST IN LANE 3 ON I480W APPROACHING MP 23.6. UNIT 2 WAS ALSO TRAVELING ON I480W NEXT TO UNIT 1 IN LANE 2. UNIT 2 MADE AN IMPROPER LANE CHANGE, STRUCK UNIT 1 IN THE LEFT FRONT, VEERED ACROSS WEST BOUND LANES STRIKING THE HIGH SPEED MEDIAN WALL AND ROLLING SEVERAL TIMES BEFORE COMING TO A STOP ON ITS ROOF IN THE HIGH SPEED EMERGENCY LANE. THE OPERATOR OF UNIT 2 STATED SHE DID NOT HAVE INSURANCE ON THE VEHICLE AND WAS TRANSPORTED TO METRO HOSPITAL FOR EVALUATION.

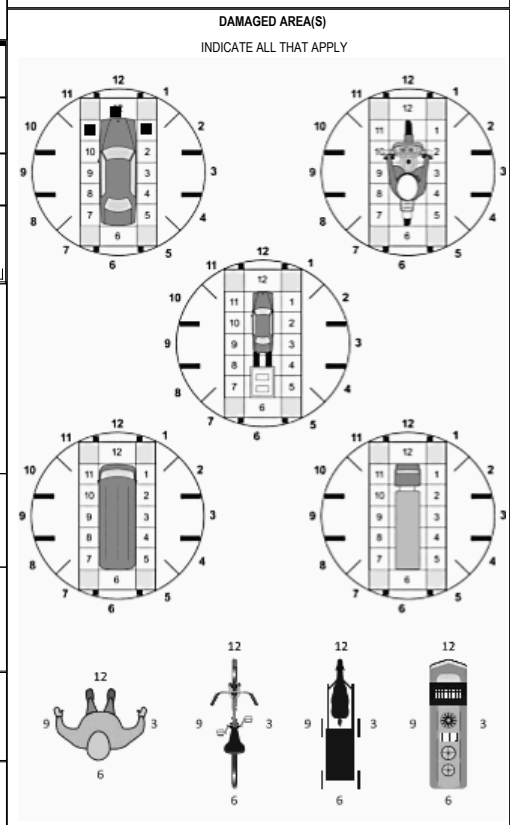
