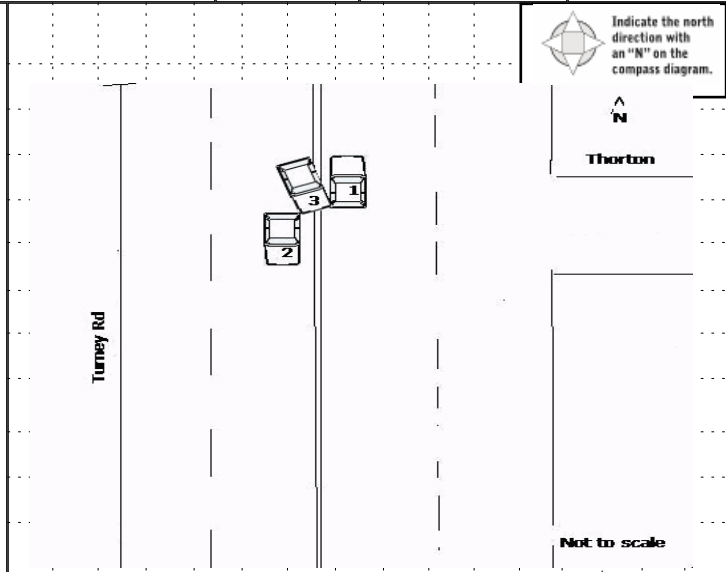

DRIVER OF UNIT 1 STATES SHE WAS STOPPED N/B ON TURNEY WAITING TO TURN LEFT (W/B) ONTO S. HIGHLAND. UNIT 3 STRUCK THE REAR OF UNIT 2 AND AS A RESULT SPUN SLIGHTLY TO THE LEFT AND STRUCK THE LEFT REAR OF UNIT 1.

DRIVER OF UNIT 2 STATES SHE WAS TRAVELING S/B ON TURNEY IN THE CENTER LANE AND OBSERVED UNIT 3 TRAVELING AT WHAT SHE DESCRIBED AS A "HIGH RATE OF SPEED". UNIT 3 THEN STRUCK THE REAR OF UNIT 2 SENDING UNIT 3 INTO THE REAR OF UNIT 1.
