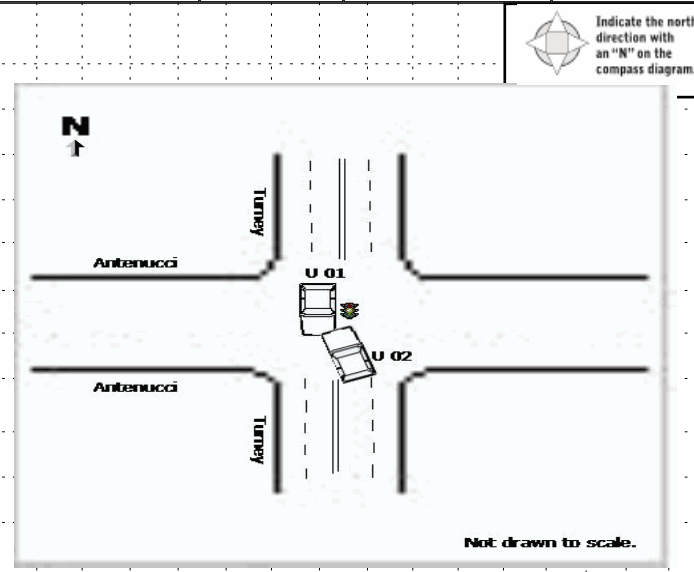

UNIT 01 WAS TRAVELING SOUTH ON TURNEY AT THE INTERSECTION OF ANTENUCCI. UNIT 02 WAS TRAVELING NORTH ON TURNEY AND ABOUT TO MAKE A LEFT/WEST TURN ONTO ANTENUCCI. AS UNIT 01 TRAVELED SOUTH THROUGH THE INTERSECTION, THE LIGHT CHANGED TO YELLOW, AND THEN UNIT 02 BEGAN TO MAKE THE LEFT TURN ALSO WITH A YELLOW LIGHT. UNIT 02 TURNED IN FRONT OF UNIT 01, CAUSING THE FRONT OF UNIT 02 TO STRIKE THE FRONT LEFT CORNER OF UNIT 01. THE WITNESS STATED THAT UNIT 02 ALSO ALMOST STRUCK HER VEHICLE AS SHE WAS TRAVELING

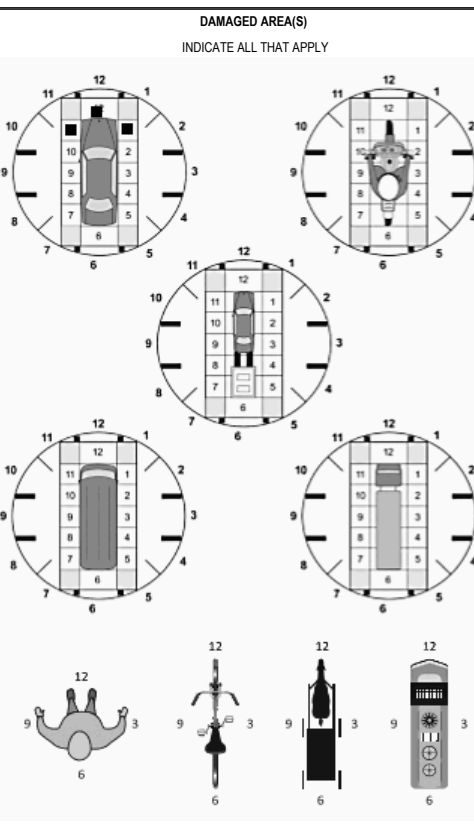

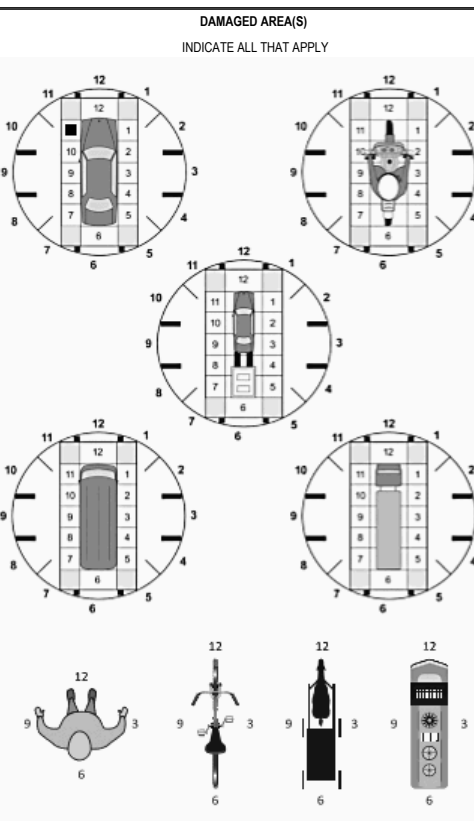
