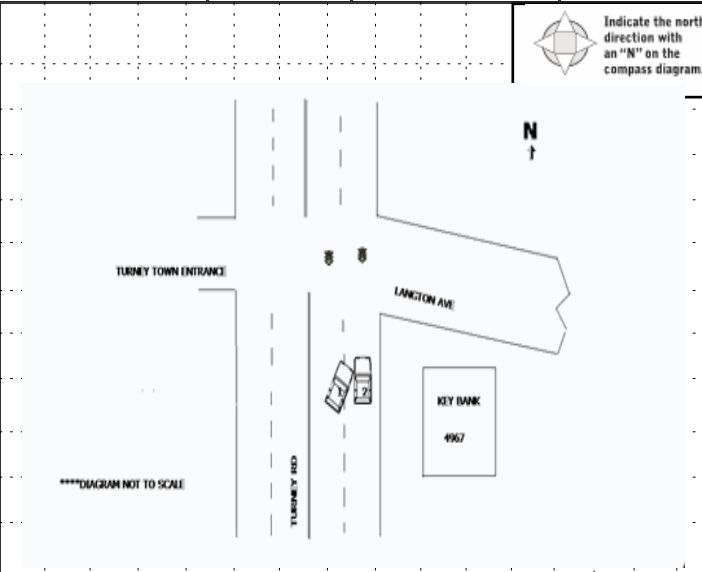

UNIT 1 ATTEMPTED TO CHANGE LANES INTO THE CURB LANE AND FAILED TO OBSERVE UNIT 2, WHICH WAS ALREADY TRAVELING IN THAT LANE. UNIT 1 STRUCK THE LEFT SIDE OF UNIT 2. NO INJURIES WERE REPORTED. BOTH VEHICLES WERE MOVED FROM THE SCENE PRIOR TO POLICE ARRIVAL.

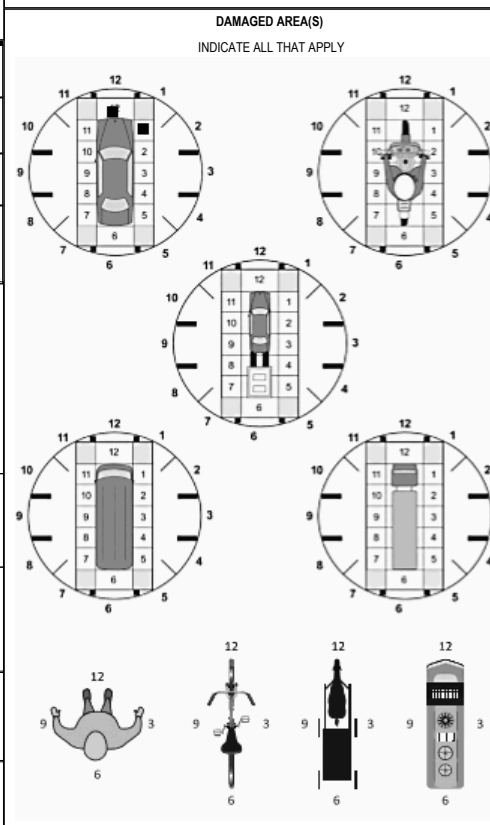

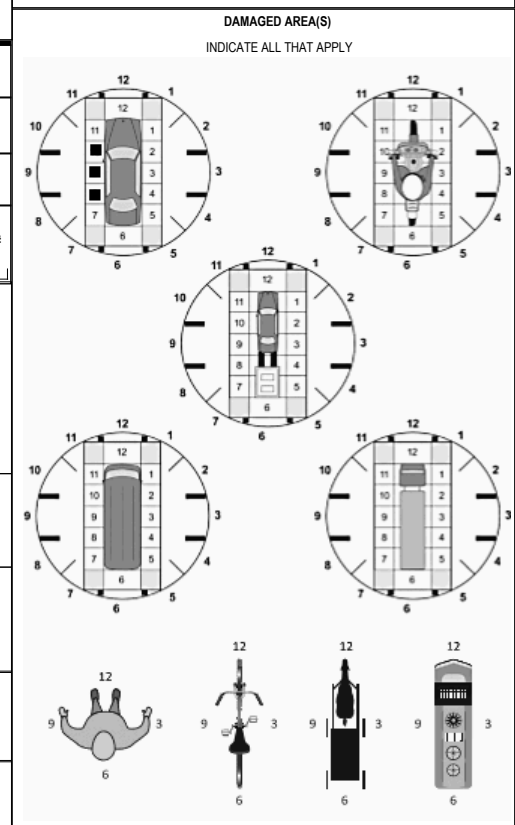
