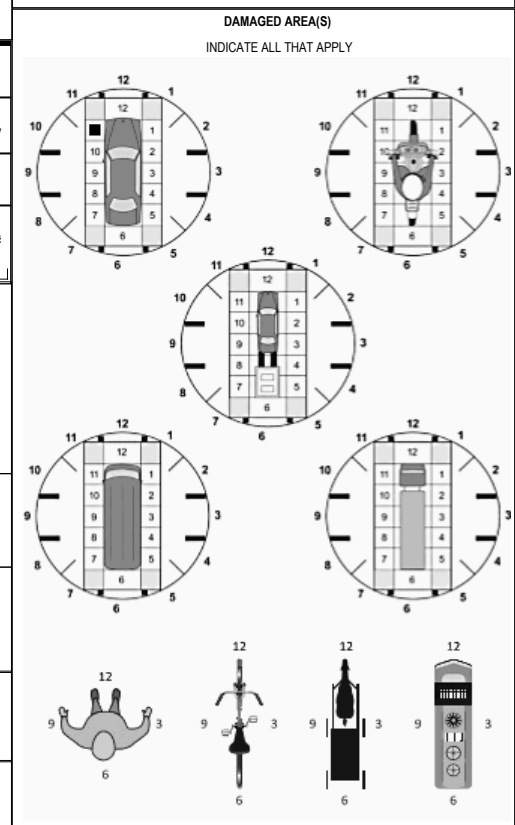

UNIT 1 BEGAN TO SPIN OUT OF CONTROL TOWARDS THE LEFT MEDIAN. UNIT 2 STATES HE WAS TRAVELING IN THE FAR LEFT LANE. AS UNIT 1 BEGAN TO LOSE CONTROL IT STRUCK UNIT 2 AT THE RIGHT SIDE. 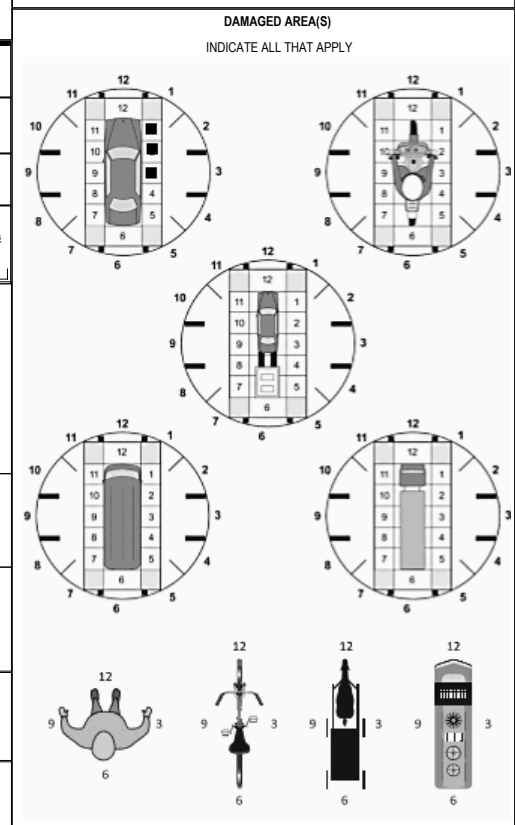
