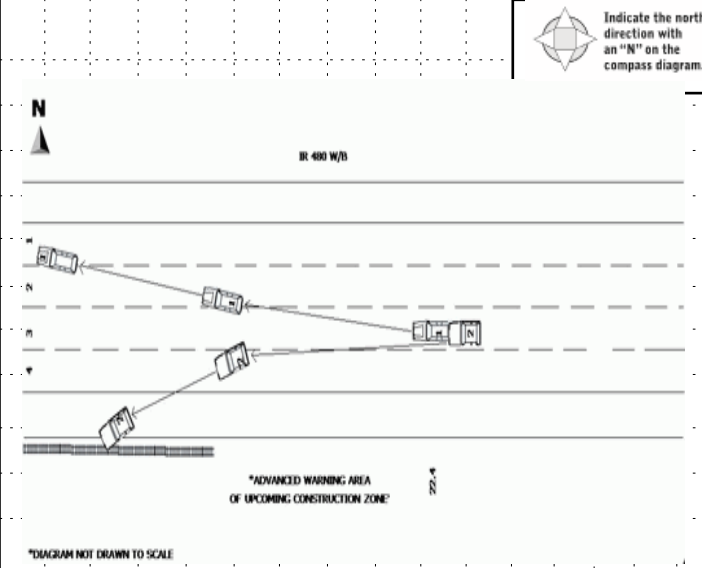

UNIT 2 FAILED TO SLOW DOWN FOR UNIT 1 CAUSING UNIT 2 TO REAR END UNIT 1. UPON IMPACT WITH UNIT 1, UNIT 2 TRAVELED TO THE LEFT ACROSS LANE #4 INTO THE HIGH SPEED BERM WHERE IT STRUCK A GUARDRAIL.

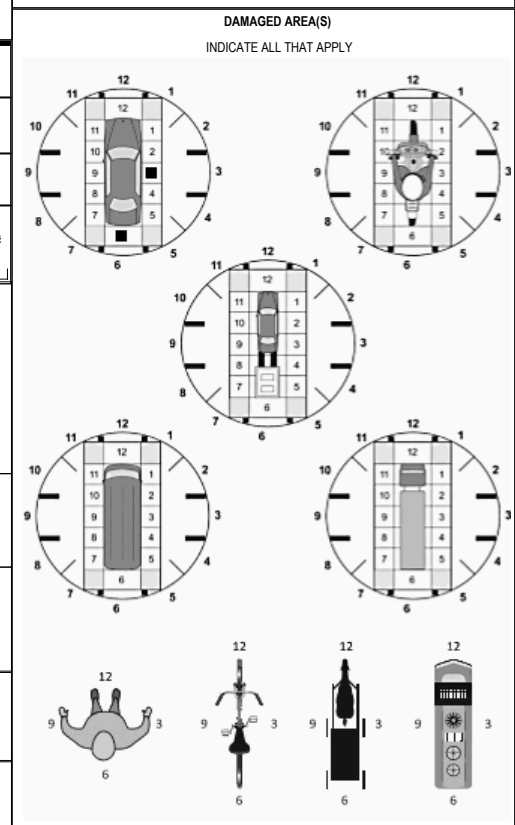
