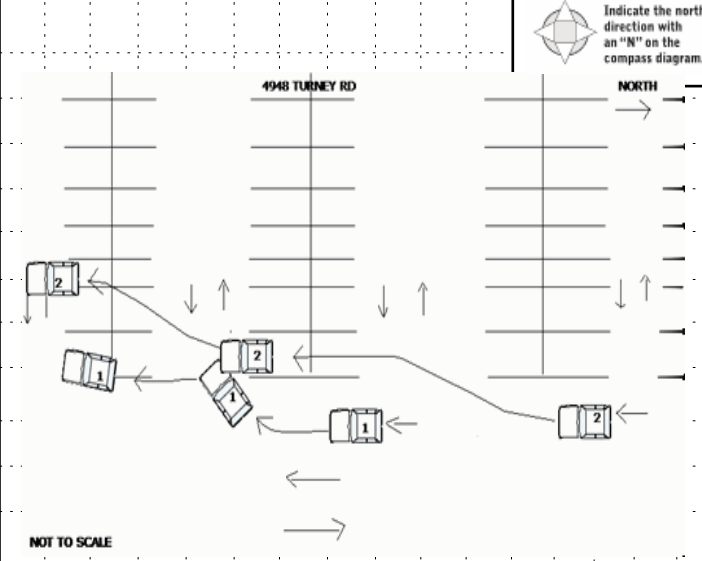

UNIT 1 THEN MADE A RIGHT TURN TO TRAVEL WEST THROUGH THE PARKING LOT IN THE WESTBOUND LANE WHEN UNIT 1 WAS STRUCK BY UNIT 2 IN THE RIGHT FRONT BY THE LEFT FRONT OF UNIT 2. UNIT 2 STATED THEY WERE TRAVELING SOUTH THROUGH THE PARKING LOT BEHIND UNIT 1. UNIT 2 THEN DROVE PARALLEL TO UNIT 1 BY TRAVELING THROUGH THE PARKING SPOTS AND NOT IN A LANE. UNIT 1 THEN MADE A RIGHT TURN AND UNIT 2 STRUCK UNIT 1.

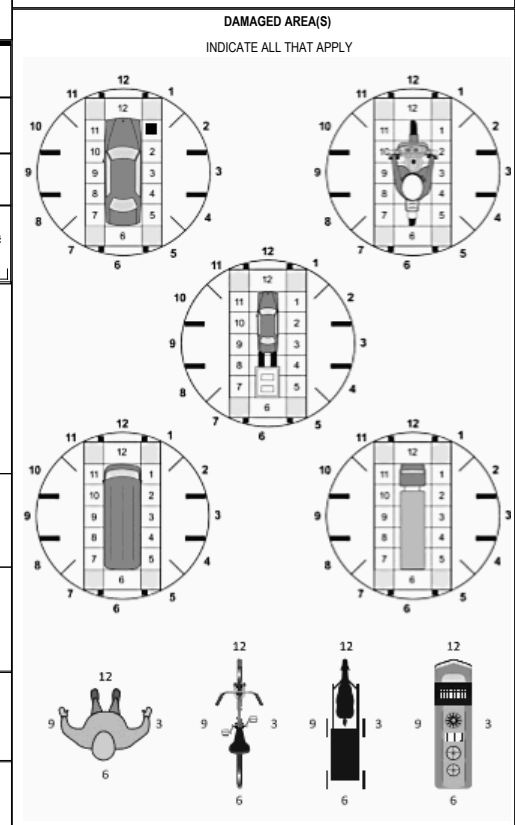
