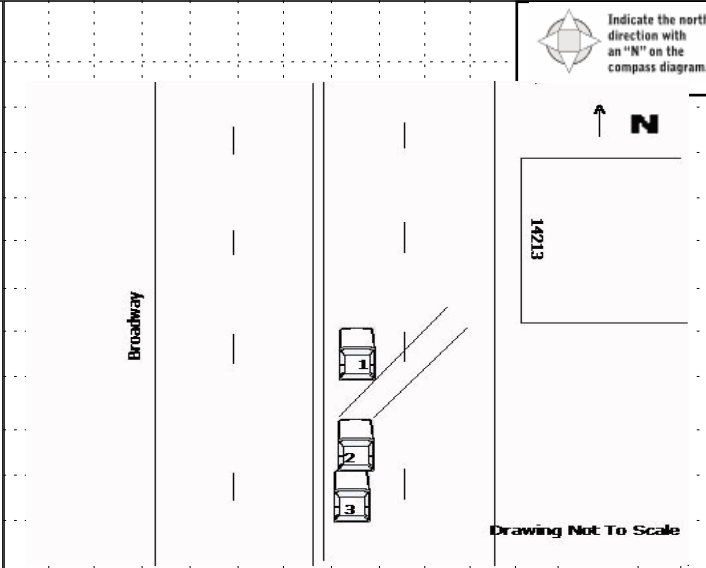

UNIT 3 WAS TRAVELING IN THE LEFT LANE NORTH ON BROADWAY DIRECTLY BEHIND UNIT 2. DRIVER OF UNIT 3 STATED SHE WAS SWATTING AT A BEE THAT FLEW INSIDE HER VEHICLE DISTRACTING HER FROM UNIT 2 SLOWING DOWN. UNIT 3 STRUCK UNIT 2 CAUSING UNIT 2 TO MOVE INTO THE RIGHT LANE STRIKING UNIT 1. DRIVER AND PASSENGER OF UNIT 2 WERE TRANSPORTED BY EMS TO MARYMOUNT

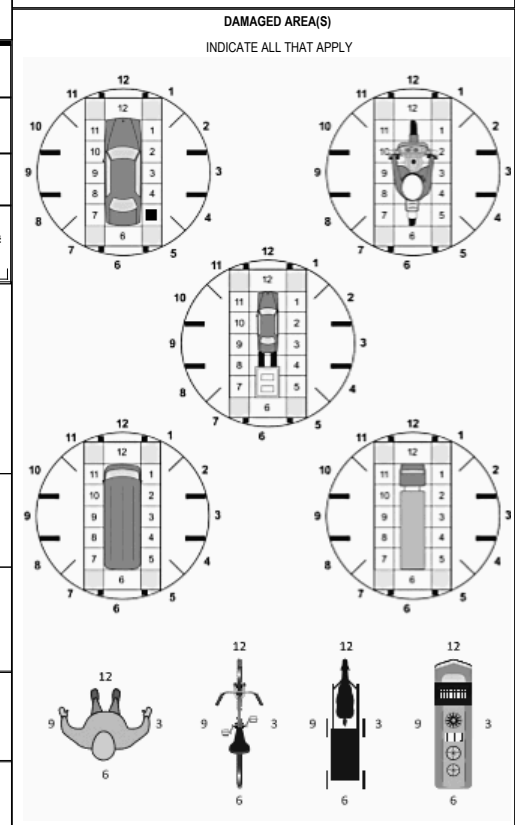

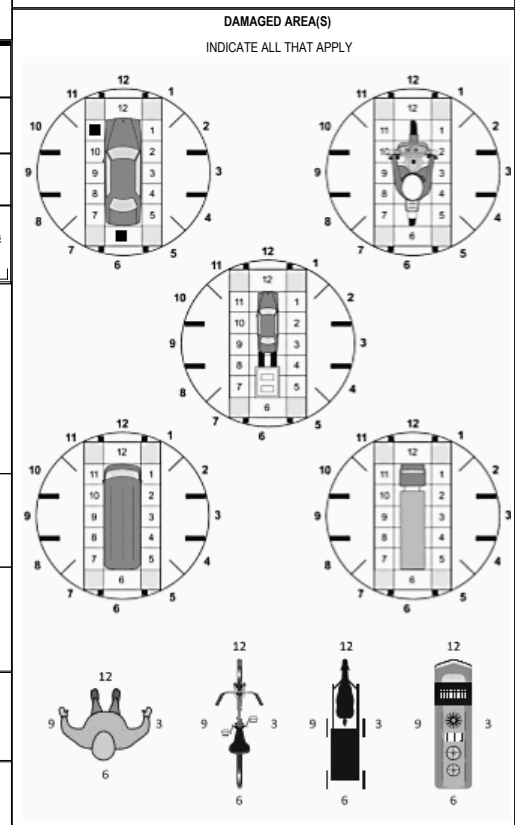

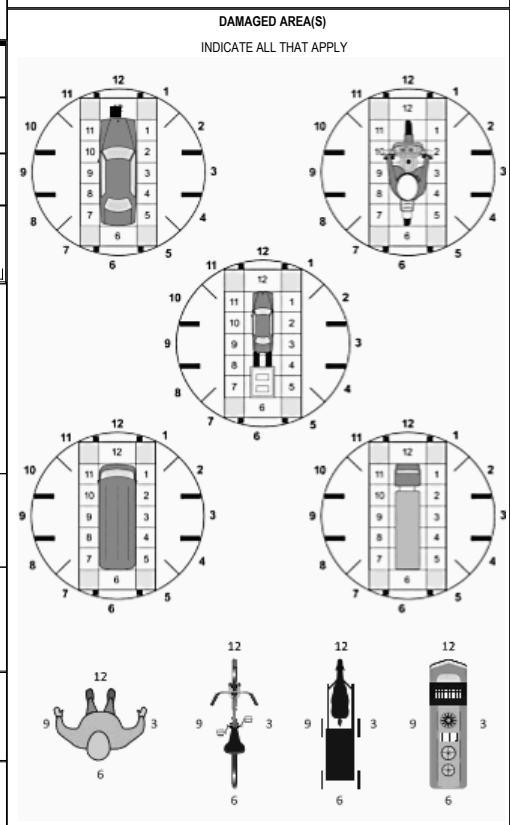
