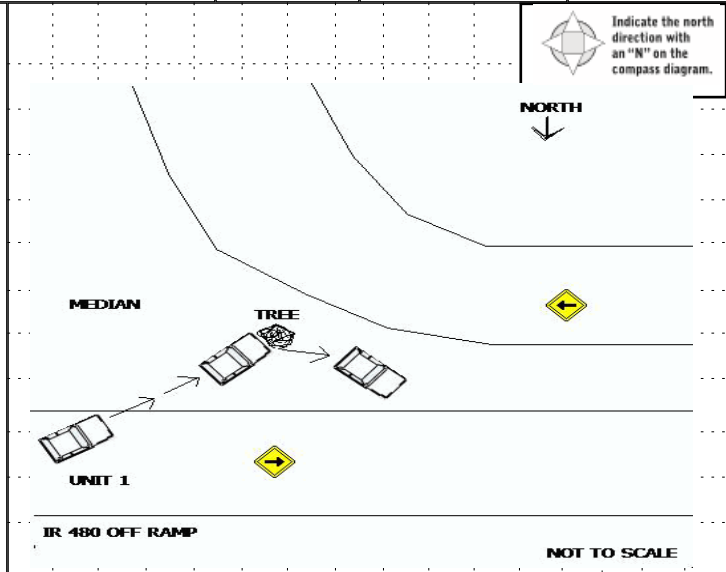

NARRATIVE

UNIT 1 WAS TRAVELING W/B ON IR 480 WEST. WITNESSES STATED THEY OBSERVED UNIT 1 RACING ANOTHER VEHICLE, POSSIBLY A BMW SEDAN. WITNESSES STATED UNIT 1 WAS TRAVELING AT A HIGH RATE OF SPEED AND CUT OVER FROM THE HIGH SPEED LANE TO THE TRANSPORTATION BOULEVARD EXIT RAMP. THERE WERE NOT WITNESSES TO THE COLLISION, HOWEVER, IT APPEARS THE DRIVER OF UNIT 1 WAS TRAVELING ON THE RAMP AT A HIGH RATE OF SPEED, LOST CONTROL OF THE VEHICLE, LEFT THE ROADWAY AND STRUCK A TREE.

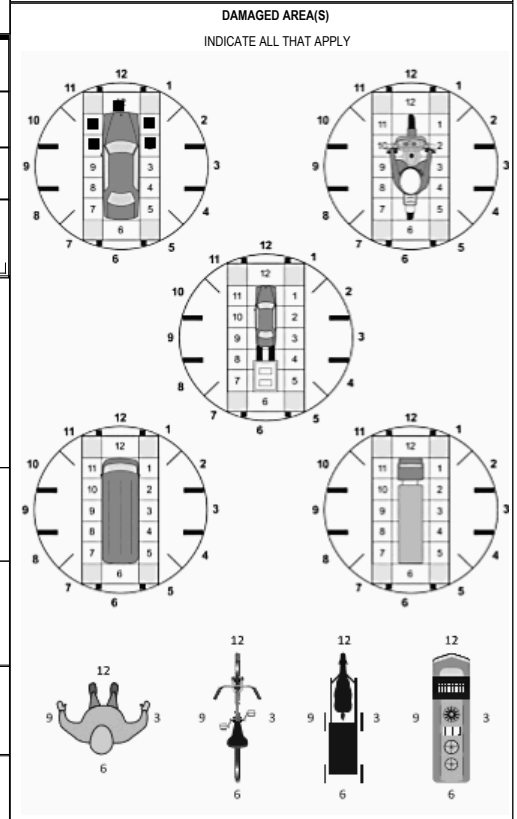
