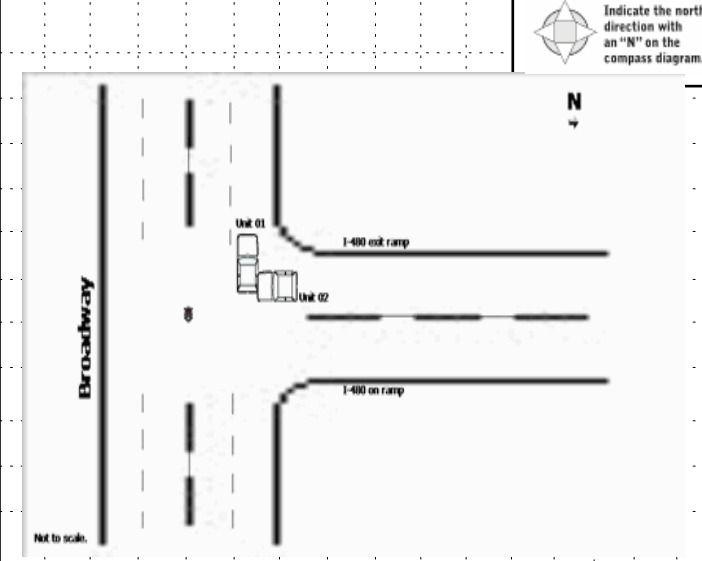

 UNIT 1 WAS TRAVELING WEST ON BROADWAY WITH A GREEN LIGHT AT THE I-480 RAMP INTERSECTION. UNIT 2 WAS TRAVELING SOUTH ON THE I-480 EXIT RAMP APPROACHING BROADWAY AND WENT THROUGH A RED LIGHT CAUSING THE FRONT CENTER OF UNIT 2 TO STRIKE THE RIGHT REAR OF UNIT 1. AFTER THE COLLISION UNIT 2 THEN DROVE OVER THE CURB ON BROADWAY.

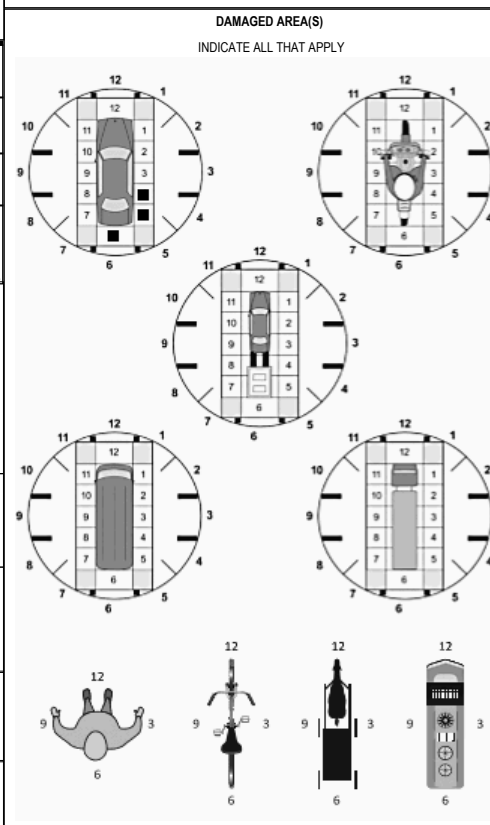

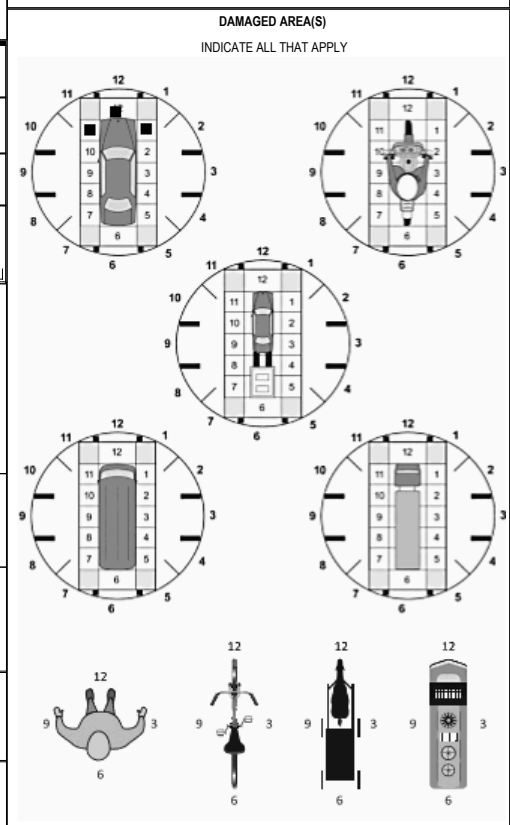
