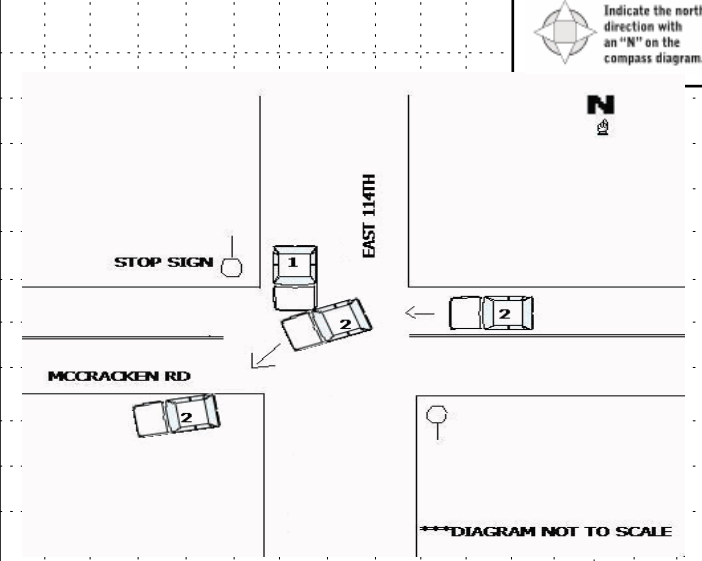

UNIT 1 STARTED TO DRIVE ACROSS THE INTERSECTION, BUT FAILED TO YIELD TO UNIT 2, WHICH WAS TRAVELING W/B ON MCCRACKEN RD AND HAD THE RIGHT OF WAY. UNIT 1 STRUCK THE RIGHT SIDE OF UNIT 2, CAUSING UNIT 2 TO DRIVE OFF THE ROAD TO THE LEFT. NO INJURIES WERE REPORTED.

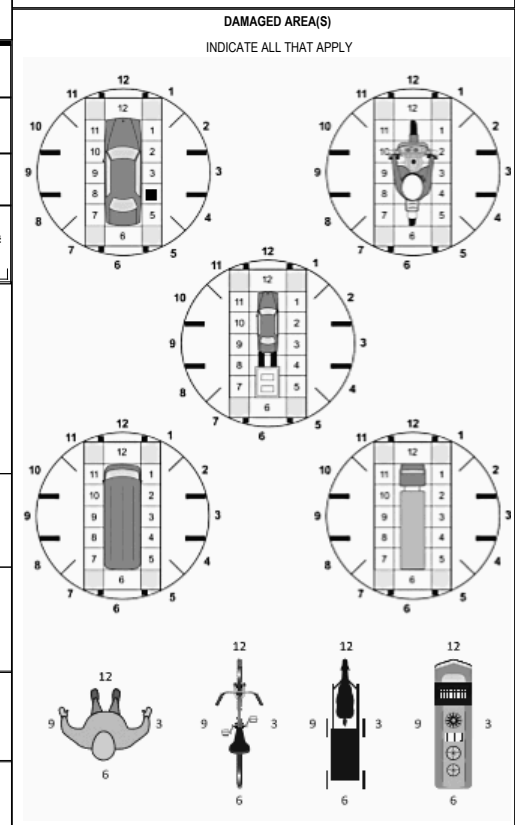

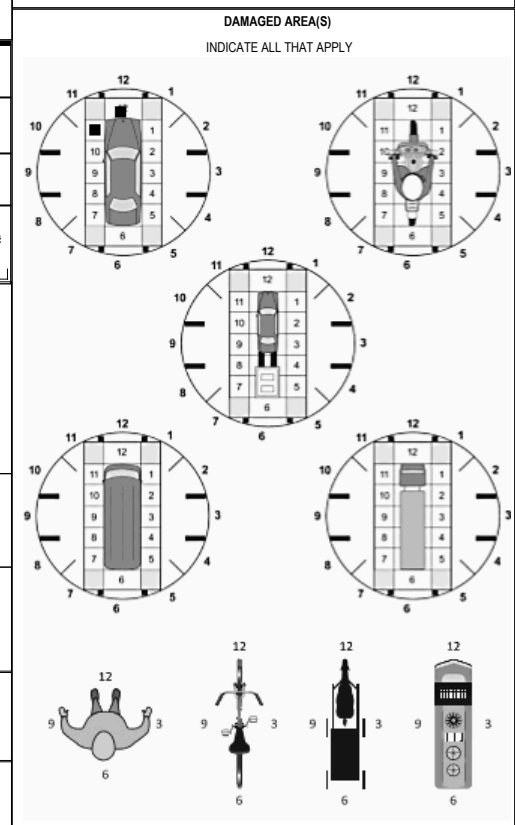
