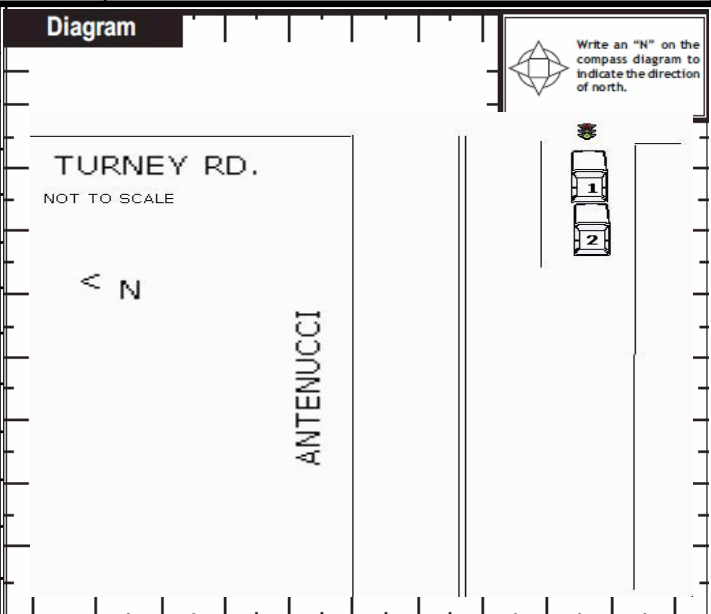

UNIT #1 AND #2 WERE IN THE RIGHT TURNING LANE ON ANTENUCCI AT TURNEY. THE DRIVER OF UNIT #2 STATED THE DRIVER OF UNIT #1 WAS STOPPED AT THE GREEN ARROW FOR AWHILE PLAYING WITH HIS PHONE. HE THEN MOVED AHEAD, THEN STOPPED. UNIT #2 STRUCK UNIT #1 FROM BEHIND. THE DRIVER OF UNIT #2 STATED HE CAN'T REMEMBER THE COLOR OF THE TRAFFIC SIGNAL OR IF HE WAS STOPPED OR MOVING WHEN STRUCK. BOTH VEHICLES HAD NO DAMAGE. UNIT #2 BENT HER FRONT LICENSE PLATE AND CRACKED HER LICENSE FRAME BUT THERE WAS NO DAMAGE TO THE CAR.




