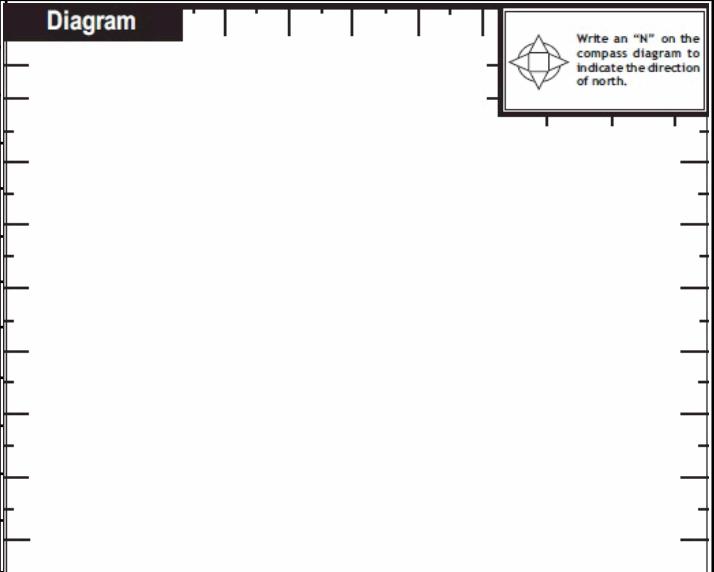

OWNER OF UNIT 1, CAME INTO THE STATION TO REPORT SHE WAS THE VICTIM OF A HIT-SKIP. AT APPROXIMATELY 5:30PM, MS. JONES EXITED GIANT EAGLE SUPERMARKET AND DISCOVERED HER VEHICLE HAD BEEN STRUCK IN THE DRIVER'S SIDE REAR. JONES DID NOT LOCATE A NOTE OR ANY VEHICLES IN THE AREA. OFC. SIMIA INSPECTED THE DAMAGE AND IT APPEARS THE HIT-SKIP VEHICLE WAS EITHER DARK GRAY OR BLACK IN COLOR. NO OTHER INFORMATION WAS AVAILABLE/PROVIDED AT THIS TIME. JONES STATES SHE WAS PARKED IN ONE OF THE CENTER ISLES, NEXT TO A SHOPPING CART CORRAL.
